- 1. Applicants own the upland property adjoining the lease premises.
- 2. On March 1, 1995, the Commission authorized a Recreational Pier Lease with James E. Teel and Joyce Raley Teel. That lease expired on February 28, 2005. Applicants are now applying for a new Recreational Pier Lease. Applicants qualify for a Recreational Pier Lease because they
