# AREA, LAND TYPE, AND LOCATION:

0.30 acres, more or less, of submerged lands in the Sacramento River, seven miles downstream of Tisdale Bypass, near the town of Robbins, Sutter and Yolo counties.

#### **AUTHORIZED USE:**

Continued use and maintenance of a 12-inch diameter welded steel carrier pipeline, containing an eight inch diameter natural gas product pipeline inside the carrier pipeline, and an abandoned-in-place 8-inch diameter natural gas pipeline.

# LEASE TERM:

20 years, beginning October 15, 1998.

#### CONSIDERATION:


