GENERAL LEASE- INDUSTRIAL USE

APPLICANT:

Silverking Oceanic Farms, Inc.
P. O. Box 254
Davenport, CA 95017

AREA, LAND TYPE, AND LOCATION:

4.132 acres, more or less, of sovereign lands in the Pacific Ocean, offshore of Davenport Landing, Santa Cruz County.

AUTHORIZED USE:

Continued operation and maintenance of two concrete fishways and four 24-inch diameter water intake lines for an upland aquaculture production facility.

LEASE TERM:

20 years, beginning March 1, 2006.

CONSIDERATION:

\$1,275 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

Bond:

Surety bond in the amount of \$5,000.

OTHER PERTINENT INFORMATION:

1. Applicant has the right to use the uplands adjoining the lease premises.
2. On February 27, 1996, the Commission authorized a General Lease-Industrial Use with Silverking Oceanic Farms, Inc. The lease will expire

February 28, 2006, and Silverking Oceanic Farms, Inc. is now applying for a new General Lease - Industrial Use.

3. The Applicant operates an upland aquaculture facility pursuant to California Department of Fish and Game (DFG) Code Section 15101 and is registered with the DFG (Registration No. 00638). The registration with DFG authorizes the Applicant to engage only in the cultivation of red and black abalone, which are native species.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

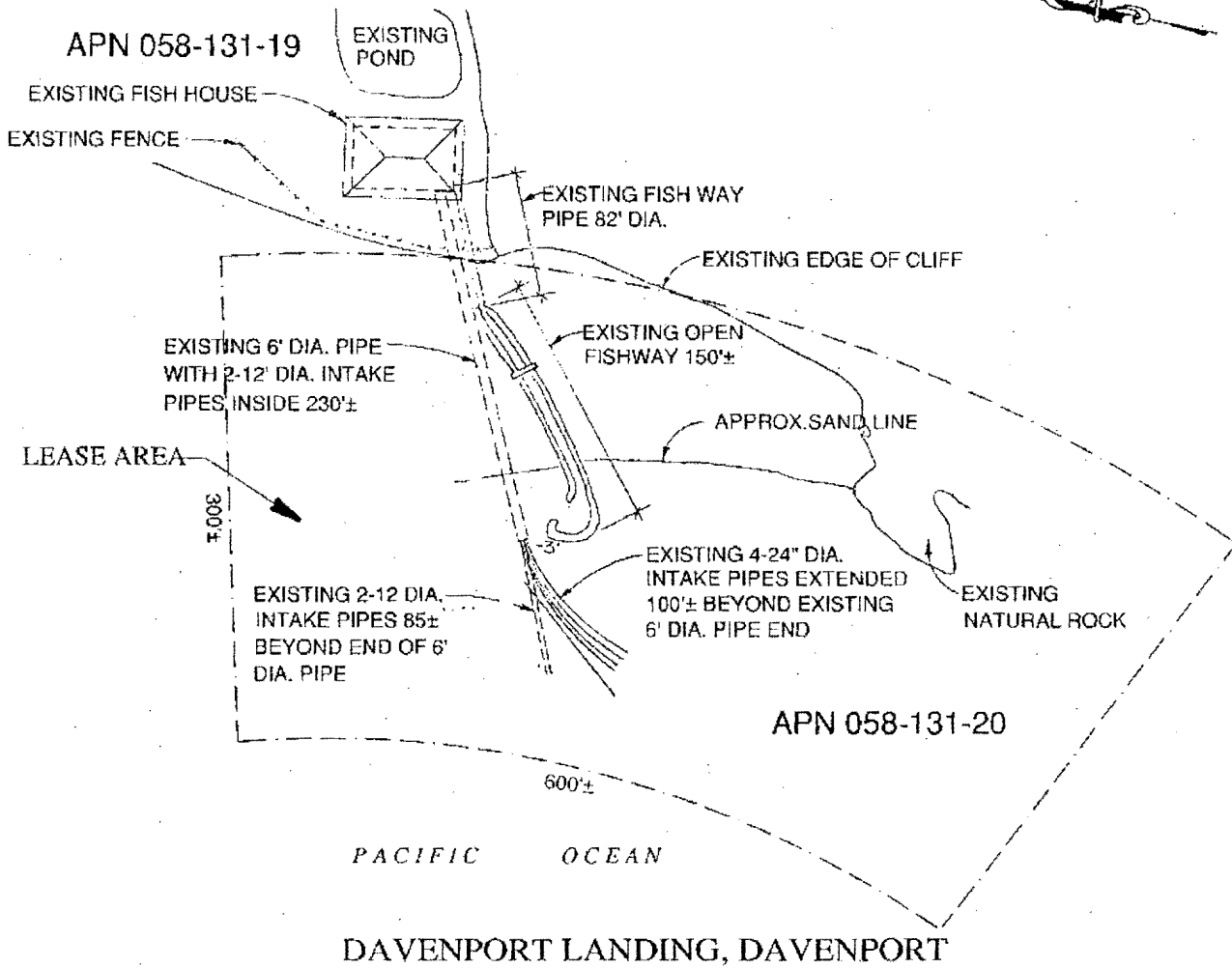

AUTHORIZATION:

AUTHORIZE ISSUANCE TO SILVERKING OCEANIC FARMS, INC. OF A GENERAL LEASE - INDUSTRIAL USE, BEGINNING MARCH 1, 2006, FOR A TERM OF 20 YEARS, FOR THE CONTINUED OPERATION AND MAINTENANCE OF TWO CONCRETE FISHWAYS AND FOUR 24-INCH WATER INTAKE LINES FOR AN UPLAND AQUACULTURE PRODUCTION FACILITY AS SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; CONSIDERATION: \$1,275 PER YEAR; WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE WITH COVERAGE OF NO LESS THAN \$1,000,000; SURETY BOND IN THE AMOUNT OF NO LESS THE \$5,000.

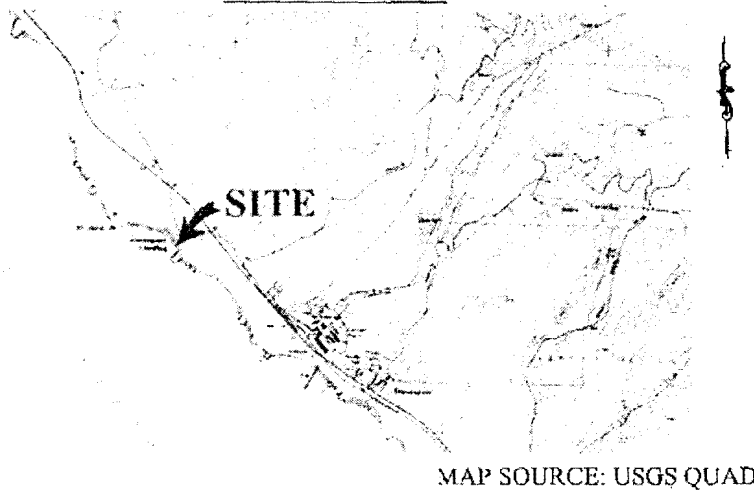
