# **APPLICANTS:**

Kjell H. Qvale, trustee of the Kjell H. Qvale Survivor's Trust and Kjell H. Qvale, trustee of the Kathryn Qvale Administrative Trust each as to an undivided 50% interest

# AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier, and the retention of one existing mooring buoy as shown on the attached Exhibit A.

#### LEASE TERM:

Ten years, beginning May 18, 2005.

#### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on the Applicants obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoy within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

1. Applicants own the upland property adjoining the lease premises.

- 2. On October 17, 1995, the Commission authorized a Recreational Pier Lease with Robert G. Dolton and Barbara Mae Dolton, trustees. That lease expired on March 26, 2005. The upland property ownership has since transferred to Kjell H. Qvale, trustee of the Kjell H. Qvale Survivor's Trust and Kjell H. Qvale, trustee of the Kathryn Qvale Administrative Trust each to an undivided 50% interest by grant deed recorded on May 18, 2005.
- 3. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Applicants are now applying for a new Recreational Pier lease for the previously authorized pier and for the retention of a mooring buoy not previously authorized by the Commission.
- 4. **Pier:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations section 2905 (a)(2).

5. **Buoy:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(3).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating

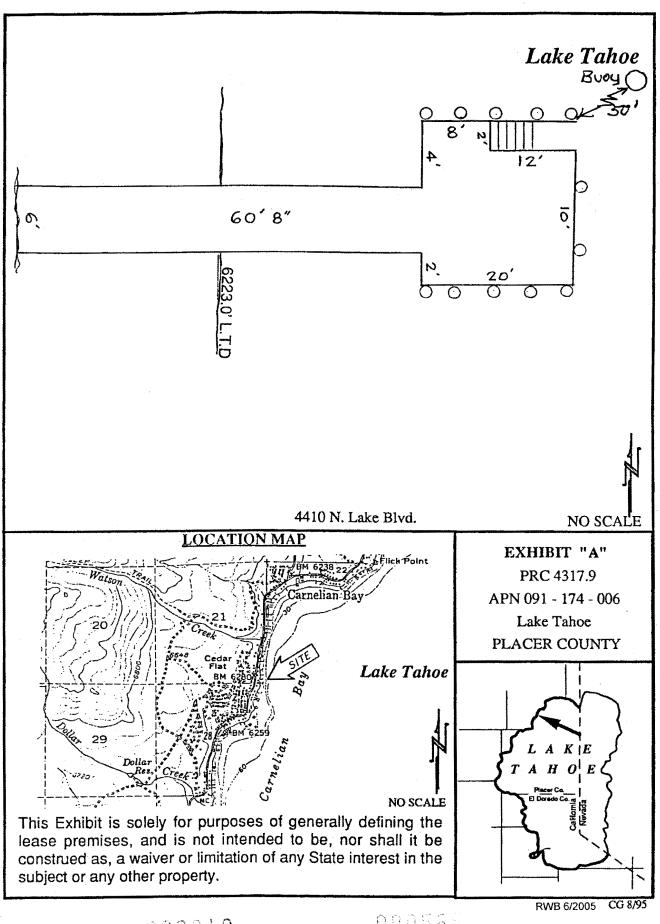
