CONTINUATION OF RENT

LESSEE:

Level 3 Communications, LLC

AREA, LAND TYPE, AND LOCATION:

0.47 acres, more or less, of State school land located in Section 36, Township 15 North, Range 7 East, SBM, near Silver Lake, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of 12 existing uncased high-density polyethylene (HDPE) innerducts, one of which contains one fiber optic cable with approximately 144 fibers.

LEASE TERM:

Ten years, beginning April 1, 2001.

CONSIDERATION:

This lease provides that the Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$426 per year, effective April 1, 2006.

OTHER PERTINENT INFORMATION:

1. On April 24, 2001, the Commission authorized a General Lease – Non-Exclusive Right Of Way Use to Level 3 Communications, LLC for a term of ten years. This lease will expire on March 31, 2011. The lease is for 12 existing uncased (HDPE) innerducts, one of which contains one fiber optic cable with approximately 144 fibers. These innerducts are installed underground and are part of a segment of a national long-haul transmission network for voice and data services.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.

Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, sections 15060(c)(3) and 15378.

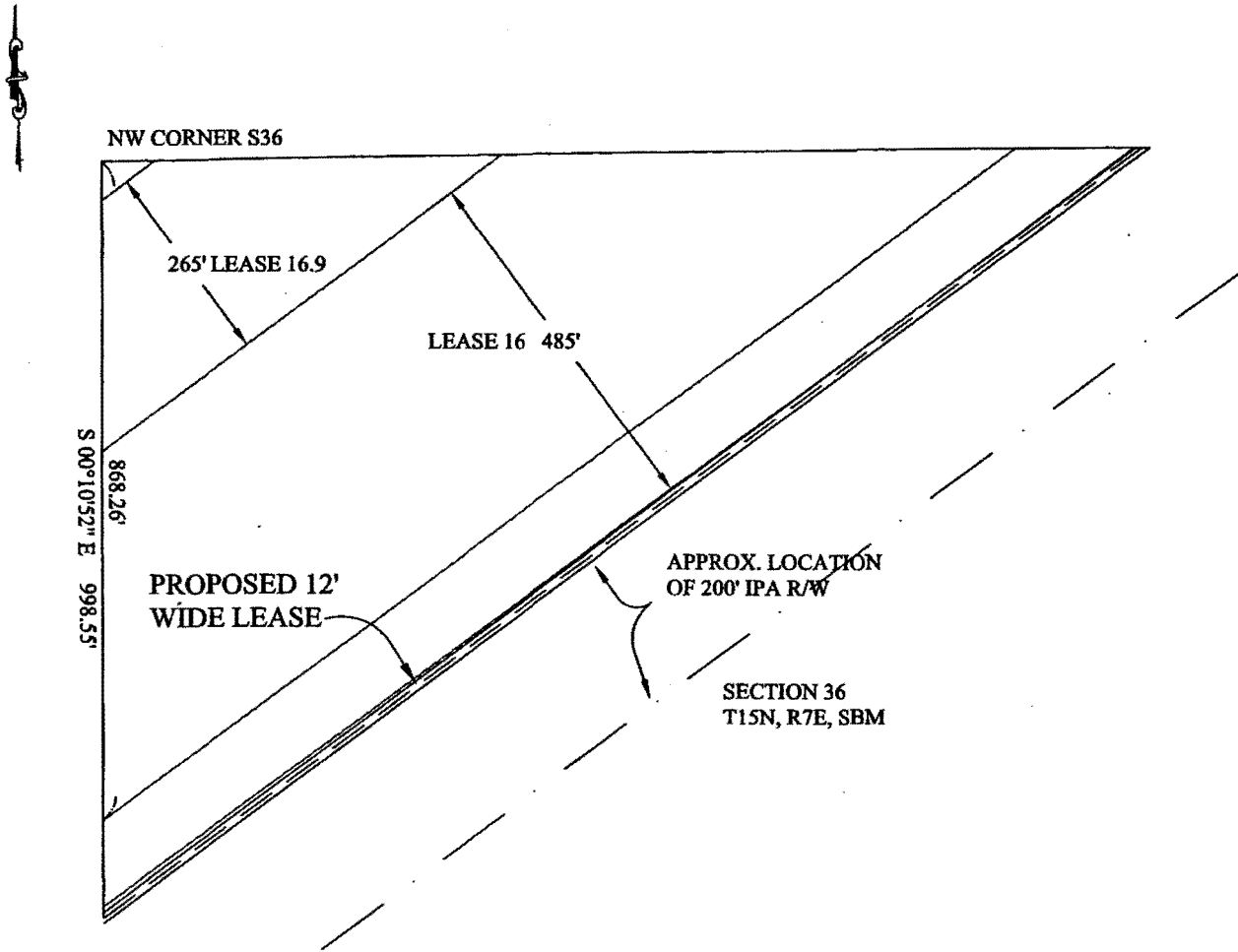

LOCATION MAP

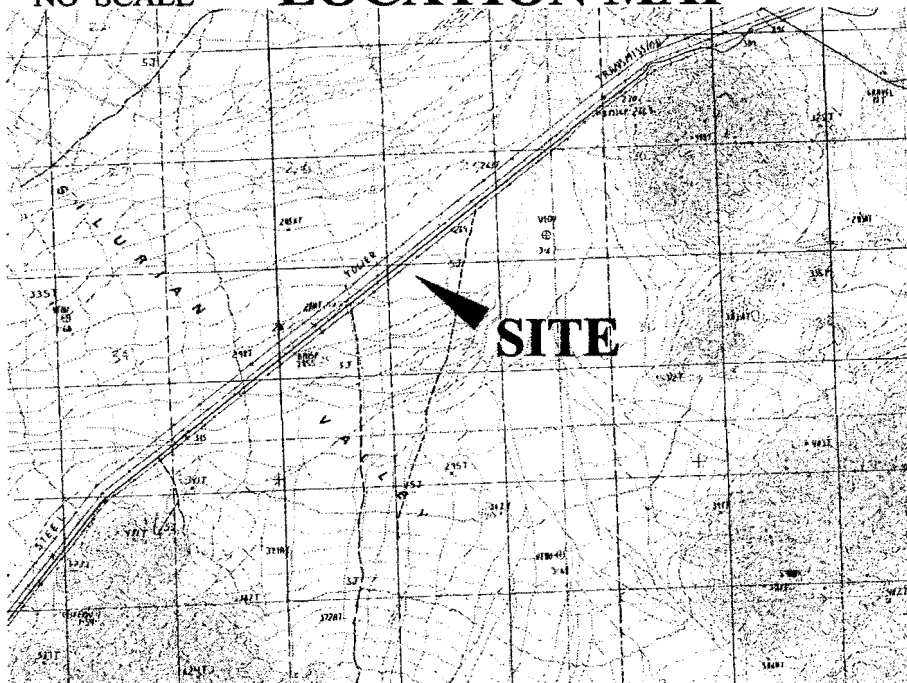
