REVISION OF RENT

**LESSEE:**

Delta Gas Gathering, Inc.  
2891 Gold Canal Drive  
Rancho Cordova, CA 95670

**AREA, LAND TYPE, AND LOCATION:**

0.62 acres, more or less, of tide and submerged lands in the Sacramento River, near the town of Courtland, Sacramento and Yolo counties.

**AUTHORIZED USE:**

Continued use and maintenance of an existing six-inch diameter directionally bored welded steel natural gas pipeline.

**LEASE TERM:**

20 years, beginning August 15, 1996.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$160 per year to \$206 per year, effective August 15, 2006.

**OTHER PERTINENT INFORMATION:**

1. On August 21, 1996, the Commission issued a twenty-year General Lease-Right of Way Use to Delta Gas Gathering, Inc. for the installation of a six-inch diameter directionally bored natural gas pipeline.
2. This pipeline is classified as a rural gathering line, and does not fall under the regulatory jurisdiction of any agency. Delta Gas Gathering, Inc., in a memo dated July 19, 2005, stated that the pipeline "was constructed, is operated, and maintained according to the regulations prescribed by the US Department of Transportation (49 CFR 192, Office of Pipeline Safety,

RSPA) for optimum Safety and efficiency." This pipeline was hydro-tested November 10, 2004. The pipeline's cathodic corrosion protection system uses magnesium anodes at intervals along the pipeline corridor.

# Location Map

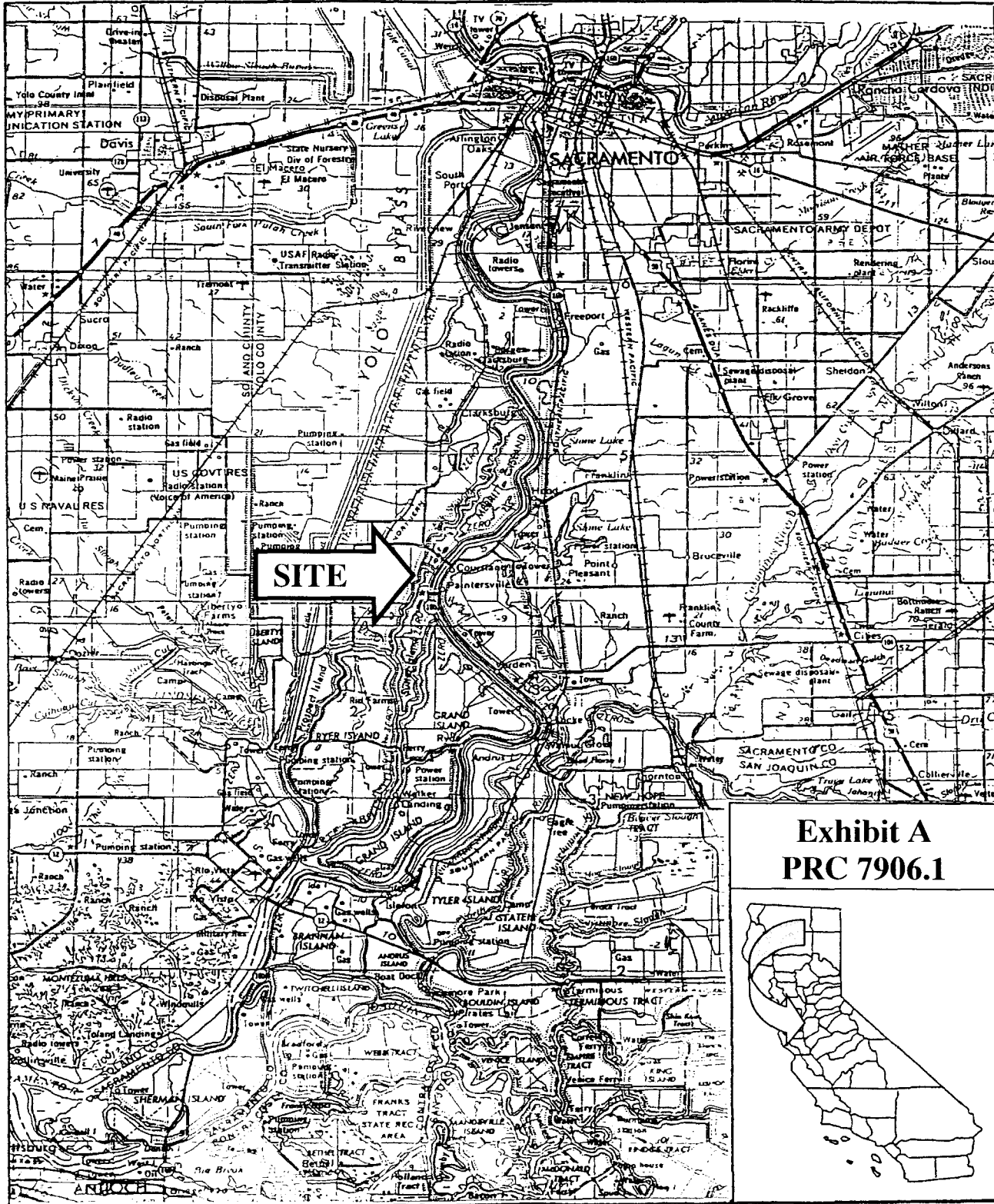


EXHIBIT CONSTRUCTED FROM USGS QUAD
