GENERAL LEASE - RECREATIONAL USE

APPLICANTS:

Ernest E. Pestana and Irene Pestana

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Carnelian Bay, Placer County.

AUTHORIZED USE:

The continued use and maintenance of a previously authorized existing pier, two boathouses with a boat lift and a boat hoist, and two decks, as shown on Exhibit A.

LEASE TERM:

Ten years, beginning August 21, 2005.

CONSIDERATION:

Two Decks: \$139 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

Pier, Two Boathouses with a Boat Hoist and a Boatlift: No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicants own the uplands adjoining the lease premises.
- 2. On February 22, 1996, the Commission authorized a Recreational Pier Lease to Ernest E. Pestana and Irene Pestana, which expired on August 20, 2005. Applicants are now applying for a new General Lease Recreational Use.

- 3. Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. The two decks located at the top of the boathouses do not qualify for rent-free status because they include facilities not used for the docking or mooring of boats. The existing pier, two boathouses with a boatlift and a boat hoist are exempt from payment of rent pursuant to Public Resources Code 6503.5.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
