**RECREATIONAL PIER LEASE**

**APPLICANT:**

Richard Wallace Myers

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Sacramento River, in the city of Sacramento, Sacramento County.

**AUTHORIZED USE:**

Construction, use, and maintenance of a new uncovered floating boat dock, gangway, and three pilings as shown on the attached Exhibit A.

**LEASE TERM:**

Ten years, beginning October 1, 2006.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the upland adjoining the lease premises.
2. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for a single-family dwelling. The Applicant is now applying for a new Recreational Pier Lease.
3. On October 13, 2006, staff signed a letter of non-objection that allowed the Applicant to start the project prior to Commission consideration.

4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

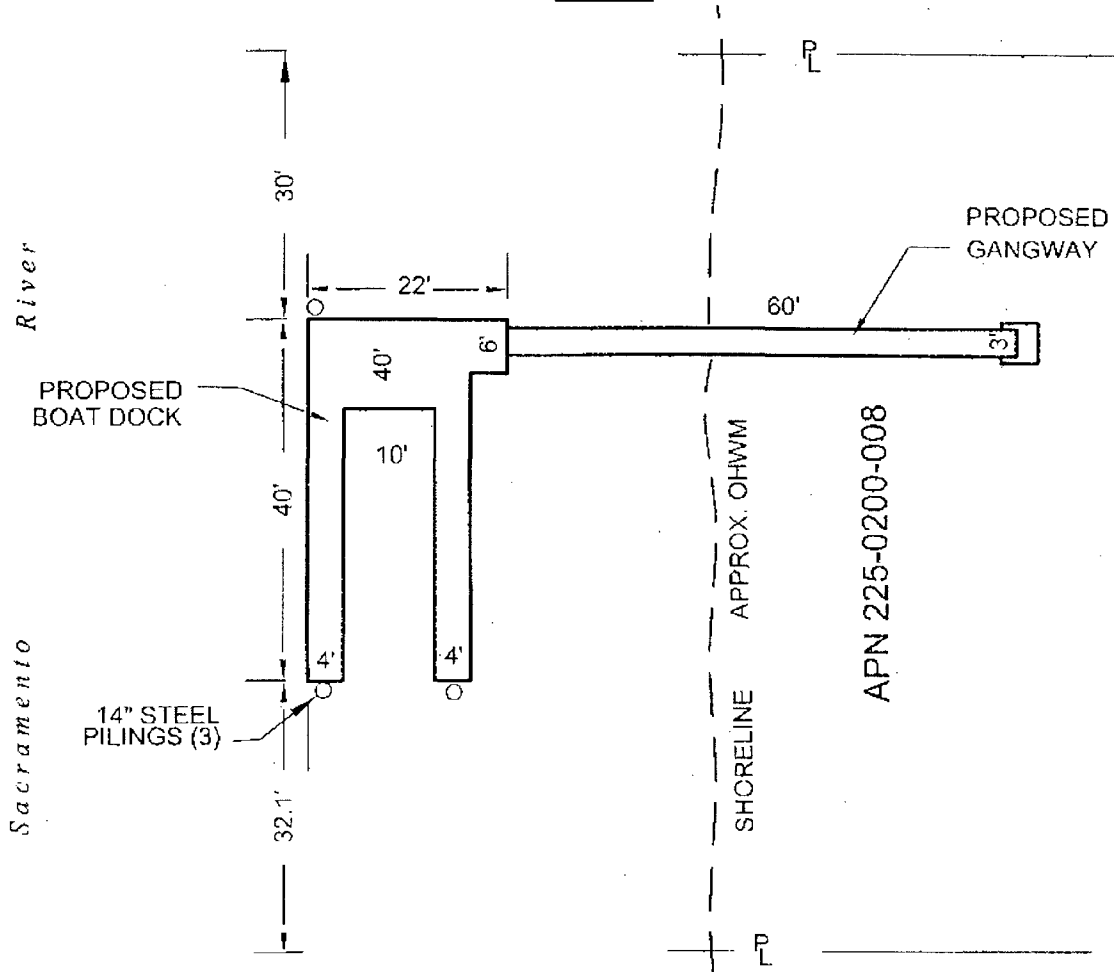

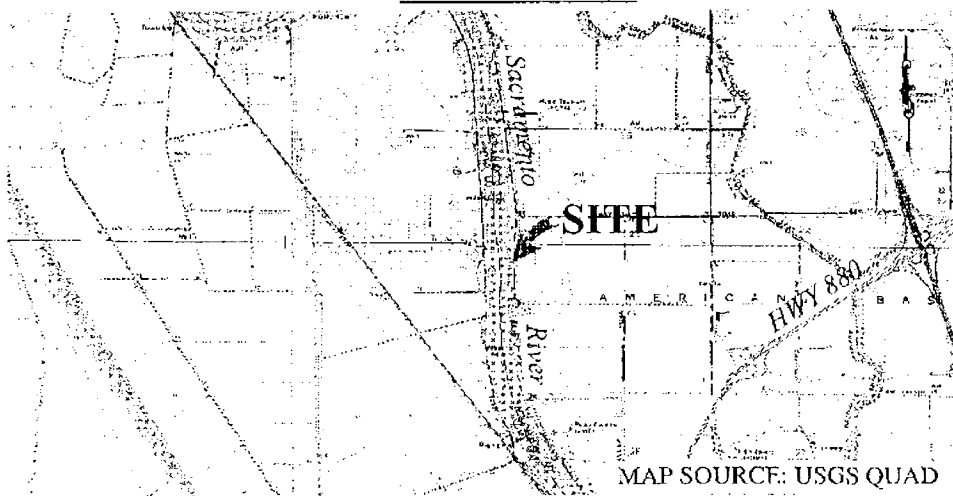
### SITE
