GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

Los Angeles County Flood Control District 900 S. Fremont Avenue Alhambra, CA 91802-1460

AREA, LAND TYPE, AND LOCATION:

0.330 acres, more or less, of tide and submerged lands in the Pacific Ocean, adjacent to the Dockweiler State Beach, near the city of El Segundo, Los Angeles County.

AUTHORIZED USE:

Continued use and maintenance of a storm drain terminus.

LEASE TERM:

25 years, beginning January 25, 2003.

CONSIDERATION:

The public health and safety; with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

Combined single limit coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has the right to use the uplands adjoining the lease premises.
- 2. On September 14, 1988, the Commission approved the issuance of a General Lease Public Agency Use, Lease No. PRC 4729.9, for a 15-year term to the Los Angeles County Flood Control District (LACFD) for a storm drain terminus adjacent to Dockweiler State Beach. The lease

expired on January 24, 2003. The LACFD is now applying for a new General Lease – Public Agency Use for the storm drain.

- 3. No changes have been made to the storm drain other than normal maintenance and repairs. Under the terms of the lease no discharge of waste into the drain is permitted. The discharge structure is designed to be covered during the summer months and mechanically exposed during winter months to allow for storm water flow. A protective railing is installed around the perimeter of the drain which serves as a safety feature when the storm drain terminus is exposed during the winter.
- 4. On December 13, 2001, the California Regional Water Quality Control Board, Los Angeles Region, issued to LACFD, its National Pollution Discharge Elimination System (NPDES) Permit No. CAS004001 in connection with the waste discharge requirements for municipal storm water and urban runoff discharges within the county of Los Angeles. On its expiration in December of 2006, the permit will remain in effect until a new permit is issued. Under the terms of Lease No. PRC 4729.9, LACFD is required to obtain and maintain all permits for the storm drain.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




