RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF DECEMBER 14, 2006

State Controller Steve Westly, Chair, called the regular meeting of the California State Lands Commission to order at 1:49 p.m. at the Port of San Diego Board Room, 1st Floor, San Diego, California 92101.

The minutes of the November 21, 2006 meeting were approved by a vote of 3-0.

Calendar Items C35, C 39 and C43 were removed from the agenda to be heard at a later meeting. Item C36 was moved from Consent to Regular.

The recommendation of staff, relative to Calendar Items C01-C34, C37-C38, C40-C42 and C44-C46, were approved by unanimous vote of Commission Chair Steve Westly, Cruz Bustamante and Anne Sheehan.

(The items appear in the order that they were heard and voted on.)

Regular Item 47: The Commission asked staff to investigate a number of alleged illegal activities by the City of Redondo Beach. A financial audit was performed and Commission staff and City of Redondo Beach staff resolved any outstanding issues, therefore, the Commission voted to approve the Memorandum of Agreement as presented by staff by a vote of 3-0.

Regular Item 48: Commissioners were asked to review the consistency of the timeshare component of the Woodfin Suites Hotel proposal with the public trust doctrine. After listening to staff reports and comments from the public, the Commission voted to approved the staff report as presented by 2 ayes and 1 abstention. (Chairman Westly left prior to voting on Item 48 and Commissioner Bustamante left after the vote.)

Calendar Item 36: The Commission was asked to approve an application for a general lease for Trans Bay Cable for the construction of a new high voltage cable to transmit power from Pittsburg to San Francisco. The item was approved as presented by a 2-0 vote.
