Lt. Governor John Garamendi, Chair, called the regular meeting of the California State Lands Commission to order at 10:30 a.m. at Council Chambers at the El Segundo City Hall, 350 Main Street, El Segundo, California 90245.

The minutes of the April 9, 2007 LNG Hearing were approved by a vote of 3-0.

Calendar Items C48 and C87 were removed from the calendar to be heard at a later date.

The recommendation of staff, relative to Calendar Items C01-C47 and C49-C86, were approved by unanimous vote of Commission Chair John Garamendi, Cindy Aronberg and Anne Sheehan.
