LESSEE:

AT&T Corp., a Wholly-Owned Subsidiary of SBC Communications, Inc. 3001 Cobb Parkway, NW-Room 162 Atlanta, GA 30339

AREA, LAND TYPE, AND LOCATION:

Three parcels of school land totaling 1.70 acres, more or less, located near the city of Barstow and near the town Mountain Pass, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of a fiber optic communications cable.

LEASE TERM:

30 years, beginning November 30, 1988.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$500 per year, effective November 30, 2007.

OTHER PERTINENT INFORMATION:




