REVISION OF RENT

LESSEE:

123096 Holdings, LLC

AREA, LAND TYPE, AND LOCATION:

0.03 acres, more or less, of sovereign lands in Donner Lake, near Truckee,
Nevada County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier as shown on the attached
Exhibit A.

LEASE TERM:

Ten years, beginning August 14, 2002.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff has conducted a review of the rent under
this lease, and recommends that the rent be revised from \$247 per year to
\$1,016 per year, effective August 14, 2007.

OTHER PERTINENT INFORMATION:

1. Lessee owns the upland property adjacent to the Lease Premises.
2. Lessee does not qualify for a rent-free Recreational Pier Lease because
the Lessee is not a natural person and therefore does not meet the
qualifications pursuant to Public Resource Code section 6503.5.

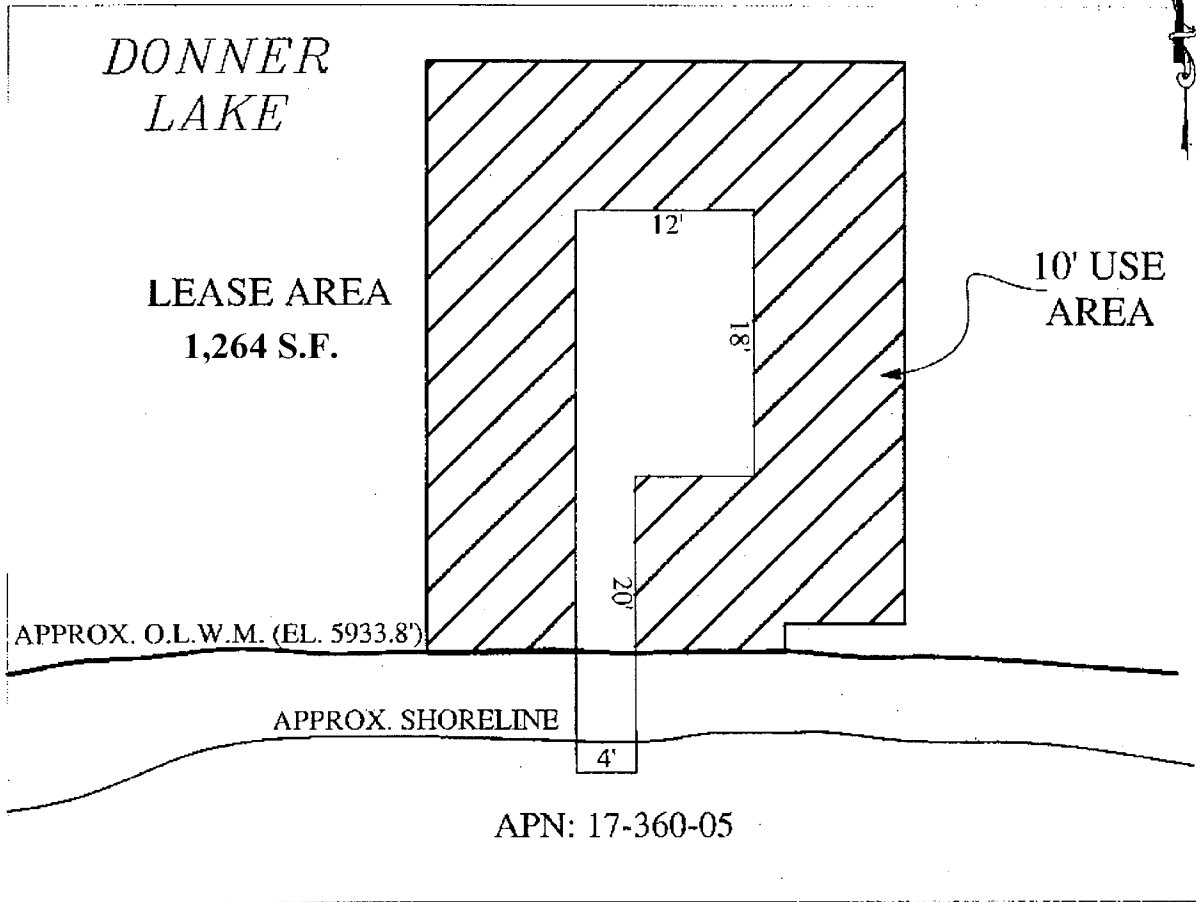

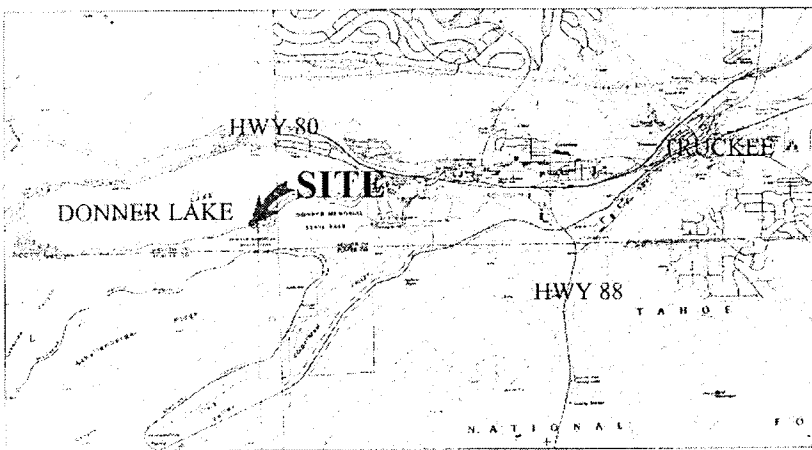
SITE
