RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF JUNE 28, 2007

Lt. Governor John Garamendi, Chair, called the regular meeting of the California State Lands Commission to order at 10:07 a.m. at the State Capitol, Room 112, Sacramento, California 95814.

The minutes of the May 10, 2007 meeting were approved by a vote of 3-0.

Calendar Items C37, C38, C40, C 41, C49, C54 and Regular Item 63 were pulled. Items C14 and C42 were moved from Consent to Regular Calendar.

The recommendation of staff, relative to Calendar Items C01-C13, C15-C36, C39, C43-C48, C50-C53 and C55-61 were approved by unanimous vote of Commission Chair John Garamendi, John Chiang and Anne Sheehan.

(The items appear in the order that they were heard and voted on.)

Regular Item 62: The Commission listened to a staff presentation on the consideration of a lease concerning construction of a covered floating boathouse with a second-story deck and handrail. The item was approved by a vote of 2-1.

Calendar Item 14: A staff presentation was made to the Commission pertaining to the construction of two temporary groundwater monitoring wells. The Commission approved the item as presented by a vote of 3-0.

Calendar Item 42: The Commission listened to a staff report concerning an application for a new lease of sovereign lands located in Tomales Bay for the Giacomini Wetland Restoration Project. The item was approved as presented by a vote of 3-0.

Regular Item 64: The Commission listened to a staff report from the Executive Officer regarding a resolution proposed by the Controller concerning opposing federal preemption of state laws that would reduce greenhouse gas emissions. The Commission approved the resolution as presented by a vote of 3-0.
