AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, South Lake Tahoe, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning April 16, 2007.

CONSIDERATION:

\$675 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant owns the uplands adjoining the lease premises.
- 2. On May 12, 1997, the Commission authorized a ten-year Recreational Pier Lease with Kenneth W. Hansen, Trustee of the Kenneth W. Hansen Revocable Living Trust. That lease expired on February 28, 2007. On April 16, 2007, the upland property was deeded to Tahoe III LLC, a Nevada Limited Liability Company. Applicant is now applying for a new General Lease Recreational Use.

- 3. Applicant does not qualify for a rent-free Recreational Pier Lease pursuant to Public Resource Code section 6503.5 because the Applicant does not own the littoral property as a natural person.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).




