No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

- Applicants own the uplands adjoining the lease premises. 1.
- On July 11, 1997, the Commission authorized a ten-year Recreational Pier. 2. Lease with Gerald Bailey and Michael J. Pease. That lease expired on May 31, 2007. Applicants are now applying for a new Recreational Pier Lease.
- Applicants qualify for a Recreational Pier Lease because they are natural 3. persons who own the littoral land that is improved with a single-family dwelling.
