RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF OCTOBER 30, 2007

Lt. Governor John Garamendi, Chair, called the regular meeting of the California State Lands Commission to order at 10:06 a.m. at the Port of San Diego, Board Room, 1st Floor, San Diego, California 92101.

The minutes of the September 13, 2007 meeting were approved by a vote of 2-0 (Garamendi and Chiang).

Regular Item 45 was pulled from the agenda.

The recommendation of staff, relative to Calendar Items C01-C44 were approved by unanimous vote of Commission Chair John Garamendi and John Chiang.

(The items appear in the order that they were heard and voted on.)

Calendar Item 46: Staff made a presentation to the Commission asking to amend the lease to adjust royalties for Hanson Marine Operations, Inc. application. The Commission voted to approve the item as presented by a 2-0 vote (Garamendi and Chiang).

Calendar Item 49: A presentation was made to the Commission asking for their consideration of a resolution supporting S.1870 and H.R. 2421, which would uphold federal protection for waters of the United States, including tributaries, wetlands, headwaters and streams. The item was approved as presented by a 2-0 vote (Garamendi and Chiang)

Calendar Item 48: The Commissioners listened to staff presentations and took testimony from the public pertaining to the application by Poseidon Resources Channelside LLC and Cabrillo Power 1 for use of sovereign lands to construct a desalination facility. The Commission decided to postpone the vote until the next meeting.

Calendar Item 47: The Commission was asked to send a letter to the San Diego Unified Port District in regards to the Port of San Diego's involvement in the San Diego Regional Water Quality Control Board cleanup and abatement order for the shipyard sediment side. The item was approved with an amendment to the letter by a vote of 2-0 (Chiang and Bugsch).

The meeting was adjourned by Controller John Chiang at 4:26 p.m.


