### RECREATIONAL PIER LEASE

### **APPLICANTS:**

James Trembath and Joanne Trembath; Clarence J. Cravalho and Mary M. Cravalho, Trustees of the Cravalho Family Living Trust, Dated August 5, 1993; Dean C. Croft and Arma B. Croft, Trustees of the Croft Family Trust dated May 20, 1993; Steve Foster and Jill Foster; Monte Lee Osborn and Mary Kay Osborn, Trustees of the 1993 Osborn Family Trust dated 7/22/93; Dean C. Croft and Bernice Croft; James R. Trembath and Joann Olvera Trembath; and William B. Seith and Mary S. Seith.

### AREA. LAND TYPE. AND LOCATION:

Sovereign lands in Lake Tahoe, near Agate Bay, Placer County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier as shown on the attached Exhibit A

### LEASE TERM:

Ten years, beginning December 3, 2007.

### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$1,000,000.

### OTHER PERTINENT INFORMATION:

- Applicants own the upland property adjoining the lease premises.
- On January 24, 1980, the Commission authorized a Recreational Pier 2. Lease with Duncan S. Davies and Robert M. Davies, et al. That lease has

expired and the property ownership has since transferred to the Applicants as tenants in common.

- 3. The Applicants qualify for a Recreational Pier Lease because they are natural persons who own the littoral land that is improved with a single-family dwelling. Applicants are now applying for a new lease for the previously authorized pier.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




