GENERAL LEASE - RECREATIONAL AND PROTECTIVE STRUCTURE USE

APPLICANTS:

Gilbert Gonzales and Margie D. Gonzales

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to the Garden Highway, near the city of Sacramento, Sacramento County.

AUTHORIZED USE:

Retention, use, and maintenance of an existing uncovered floating boat dock, three pilings, dolphin, gangway, and bank protection as shown on Exhibit A.

LEASE TERM:

Ten years, beginning February 25, 2008.

CONSIDERATION:

Uncovered Floating Boat Dock, Three Pilings, Dolphin, and Gangway: No monetary consideration pursuant to Public Resources Code section 6503.5.

Bank Protection: The public use and benefit, with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Liability insurance with combined coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

- Applicants own the uplands adjoining the lease premises.
- 2. On January 28, 2003, the Applicants purchased the upland property which included the existing uncovered floating boat dock, three pilings, dolphin, and gangway. The dock facilities were constructed in 1991 and the bank protection has existed for years. Staff has attempted, over the years, to

get the existing improvements under lease, but the prior property owners were unresponsive. The Applicants are now applying for a General Lease – Recreational and Protective Structure Use to retain the existing improvements.

- 3. The Applicants qualify for the rent free use of the uncovered floating boat dock, three pilings, dolphin, and gangway because they are natural persons who own the littoral land that is improved with a single-family dwelling.
- 4. The bank protection will mutually benefit both the public and the Applicants. The bank of the Sacramento River will have the additional protection from wave action provided at no cost to the public.
- 5. Uncovered Floating Boat Dock, Three Pilings, Dolphin, and Gangway: Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

6. **Bank Protection:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land; Title 2, California Code of Regulations, section 2905 (d)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

7. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating






