CONTINUATION OF RENT

LESSEE:

AT&T Corporation
1200 Peachtree Street, Room PA 196
Atlanta, GA 30309

AREA, LAND TYPE, AND LOCATION:

0.90 acres, more or less, of State school land in Glenn County.

AUTHORIZED USE:

Operation, use, and maintenance of a 0.50 inch diameter underground fiber optic cable.

LEASE TERM:

49 years, beginning February 27, 1996.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$100 per year, effective March 25, 2008.

OTHER PERTINENT INFORMATION:

1. On February 27, 1996, the Commission authorized a General Lease - Right of Way Use with AT&T Corporation. That lease will expire on February 26, 2045. The underground fiber optic cable extends from Bandon, Oregon, passes through the State school lands in Glenn County, and terminates in Cloverdale, Sonoma County.

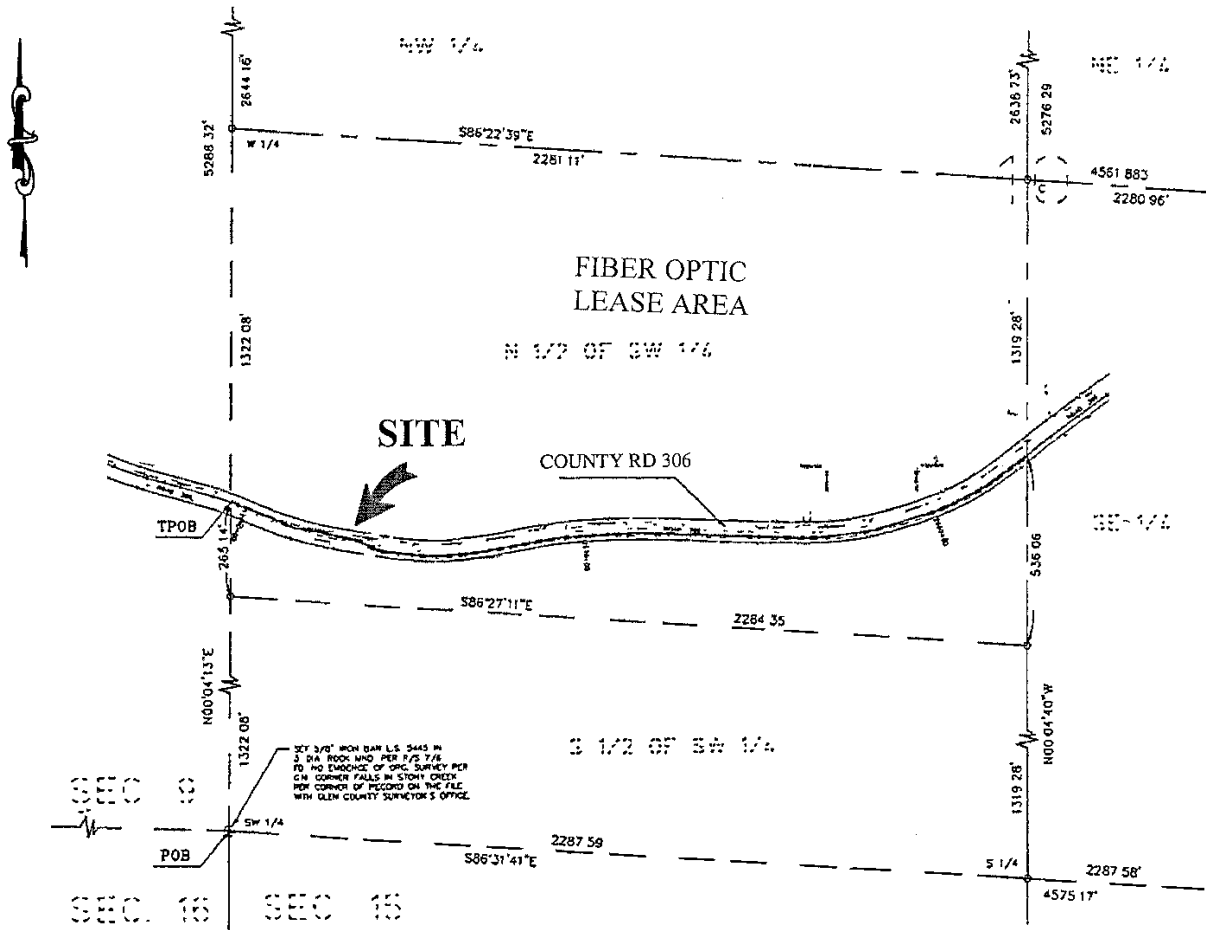

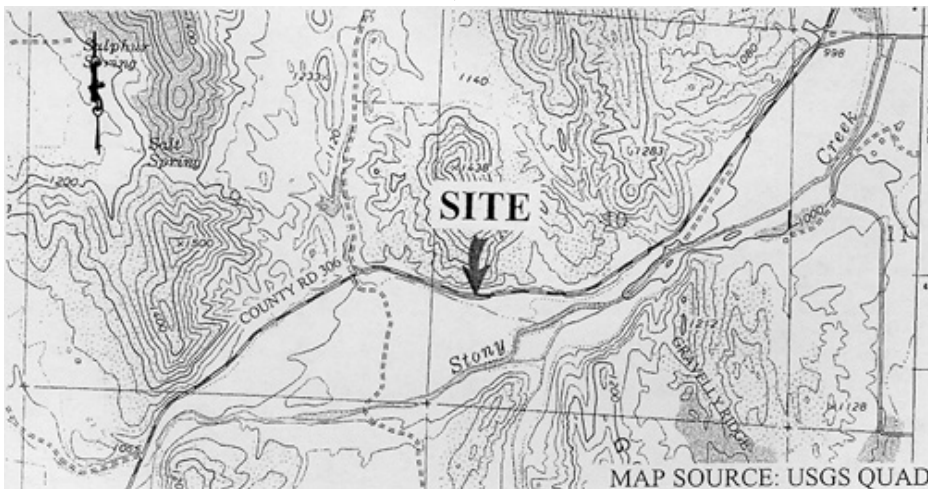
