RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF OCTOBER 16, 2008

State Controller John Chiang, Chair, called the regular meeting of the California State Lands Commission to order at 10:14 A.M. at the Port of San Diego Board Room, 3165 Pacific Highway, San Diego, California 92101. Also present were Commissioner John Garamendi and Commissioner Alternate Tom Sheehy.

The Minutes of the August 22, 2008 meeting were approved as presented by a vote of 3-0.

CONSENT CALENDAR: Consent items C17, C32 and C47 were postponed and removed from the agenda. Consent items C01-C16, C18-C31, C33-C46, and C48-C55 were approved as presented by a vote of 3-0.

REGULAR CALENDAR: Regular item 59 was postponed and removed from the agenda.

(The items below appear in the order that they were heard and voted on.)

Regular Item 56: was the consideration of a resolution opposing Proposition B, the November 4, 2008 ballot measure that would amend the Port of San Diego's Master Plan as it relates to the Tenth Avenue Marine Terminal in the city of San Diego. The item was approved by a vote of 2-0 (Finance abstained).

Regular Item 60: was a discussion on the relationship between mitigation of port operational impacts and the Public Trust Doctrine. Since this was a discussion only, no vote was taken.

Regular Item 57: a presentation was made to the Commission involving a resolution proposed by the Lt. Governor supporting the responsible development of school lands under the Commission's jurisdiction. The item was approved by a 2-0 vote (Finance and Lt. Governor's Office; the Controller's Office did not participate).

Regular Item 58: staff presented the Commission with a first-year report update on the Bolsa Chica Lowlands Restoration Project near Huntington Beach. Since this was an informational item, no vote was taken.

The Commission adjourned into Closed Session at 2:23 P.M.
