# RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION TELECONFERENCE MEETING OF MARCH 2, 2009

Lieutenant Governor John Garamendi, Chair, called the teleconference meeting of the California State Lands Commission to order at 10:00 A.M., via telephone. Also present were Commissioner Alternate, Cindy Aronberg and Commissioner Alternate, Tom Sheehy.

The Minutes of the January 29, 2009 meeting were approved as presented by a vote of 3-0

#### **CONSENT CALENDAR**

Consent item C02 was approved as presented by a vote of 3-0. Consent Item C01 was moved to the Regular Calendar.

#### **REGULAR CALENDAR**

**ITEM 01:** The Commission was asked to consider an application by AT&T Corporation for a new lease for the installation, maintenance and use of a fiber optic cable near the City of Los Osos. The Commission approved the item as amended by a 3-0 vote.

#### **PUBLIC COMMENT**

Bruce Heyman, a Dana Point Harbor boater, asked the Commission to oppose before the Coastal Commission plans for changes in the use of public trust lands in Dana Point Harbor that the county was proposing to the Coastal Commission in the form of a Local Coastal Program amendment. The Executive Officer indicated that staff had reviewed the LCP amendment and found that it was consistent with the public trust and the legislative grant. The Executive Officer also indicated that the Commission and its staff did not generally intercede in land use issues with local government trustees of legislatively granted public trust lands, except in instances where the uses were inconsistent with the trust. Staff had investigated existing uses at the harbor and informed the county of two uses inconsistent with the trust. The Executive Officer also indicated staff would continue to monitor the situation.

The Public Session of the Commission meeting was adjourned at 10:14 A.M.
