**RECREATIONAL PIER LEASE**

**APPLICANT:**

Wells Fargo Bank N.A., Trustee of the Frederick Taylor Testamentary Trust

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Lake Tahoe, adjacent to 4500 North Lake Boulevard, near Carnelian Bay, Placer County.

**AUTHORIZED USE:**

Continued use and maintenance of two existing mooring buoys as shown on the attached Exhibit A.

**LEASE TERM:**

Ten years, beginning September 27, 2008.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$500,000.

Other:

The lease contains a provision which requires the Applicant to obtain authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Final Environmental Impact Statement (FEIS) and approval of the ordinances based on the FEIS.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the upland adjoining the lease premises.
2. On September 3, 1999, the Commission authorized a ten-year Recreational Pier Lease with Wells Fargo Bank, Trustee of the Frederick Taylor Testamentary Trust. That lease expired on September 26, 2008.

CALENDAR ITEM NO. **C15** (CONT'D)

Applicant is applying for a new Recreational Pier Lease for the two mooring buoys. An existing pier is located on the upland parcel, but does not encroach below 6,223 feet Lake Tahoe Datum on State sovereign land. A lease is, therefore, not required for the pier.

3. The Applicant, Wells Fargo Bank N.A., qualifies for a Recreational Pier Lease because the beneficiary is a natural person who owns the littoral land that is improved with a single-family dwelling.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

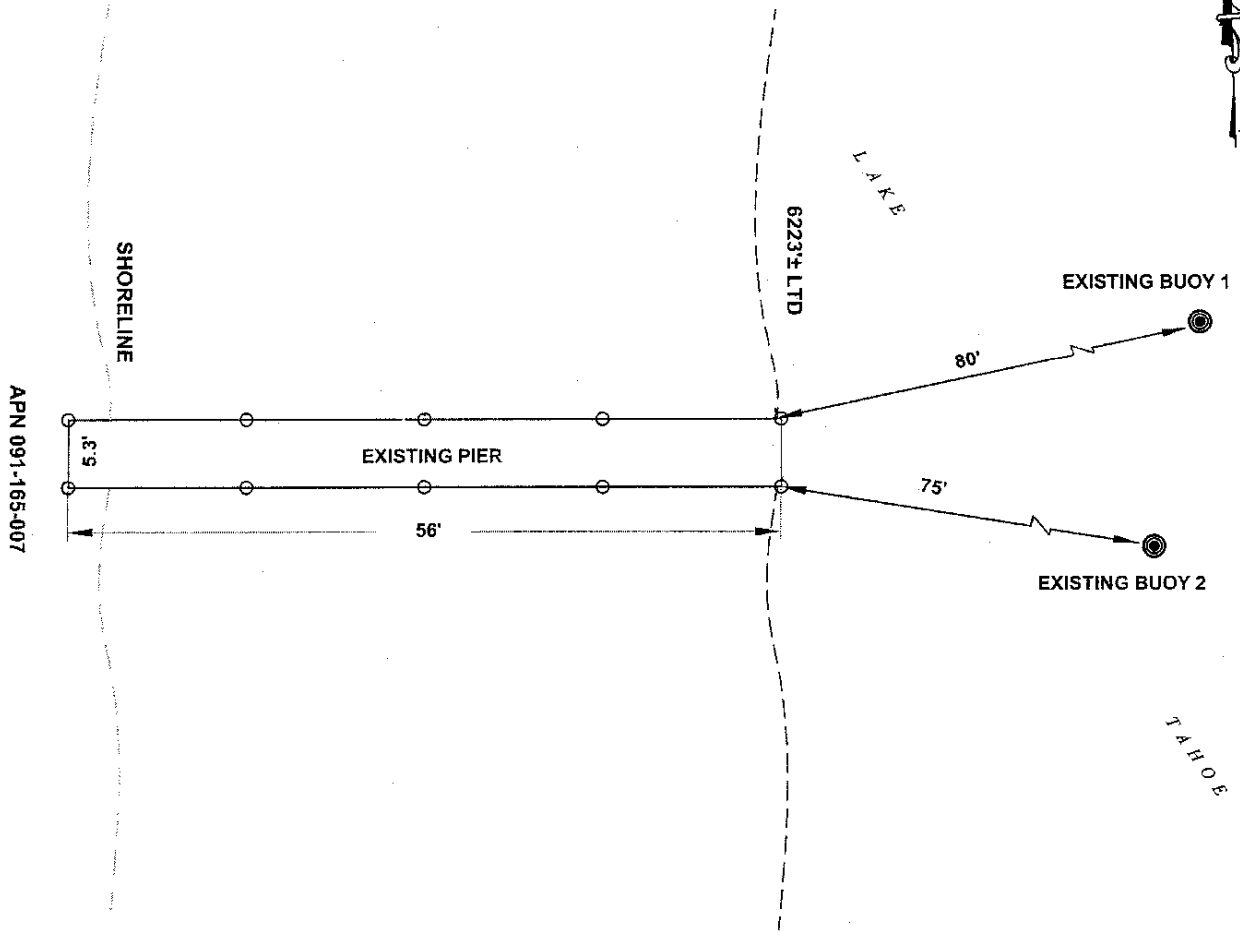

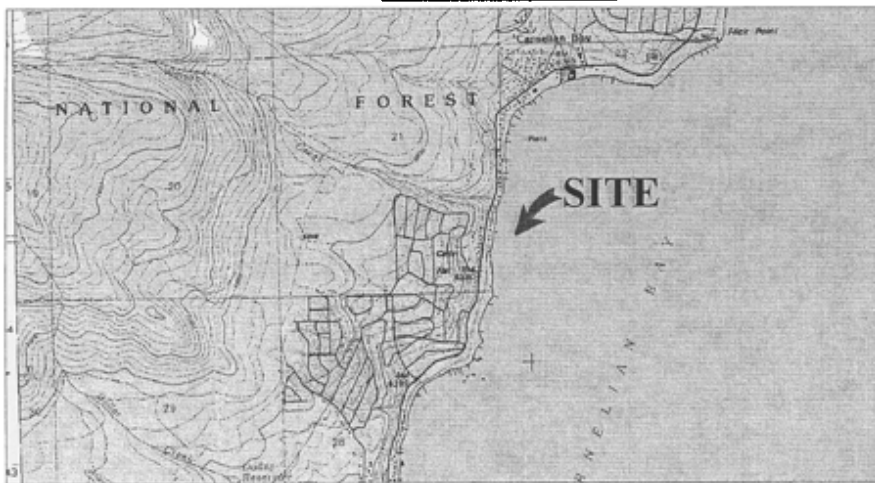
# SITE

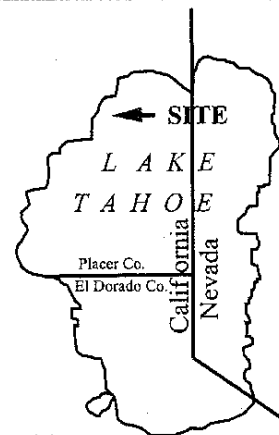
# LOCATION
