AREA, LAND TYPE AND LOCATION:

Negotiated subsurface (no surface use) State Oil and Gas Lease No. PRC 8675.1 (Lease PRC 8675.1) contains an 800 feet wide strip of tide and submerged land in the bed of the North Fork of the Mokelumne River situated in Sacramento and San Joaquin Counties, California. The parcel contains approximately 5.13 acres, and is located within the California Division of Oil, Gas and Geothermal Resources' (DOGGR) District 6, River Island Gas Field.

BACKGROUND:

Lease PRC 8675.1 was issued on April 17, 2006, to Towne Exploration Company (Towne) for a term of three (3) years. At its meeting on May 10, 2007, the California State Lands Commission (Commission) approved the assignment of an undivided forty percent (40%) interest of Lease PRC 8675.1 to Capitol Oil Company (Capitol) effective June 1, 2007. On May 5, 2008, the Commission approved the assignment of all forty percent (40%) of Capitol's interest in Lease PRC 8675.1 to ABA Energy Corporation (ABA) effective June 1, 2008.

On March 21, 2008, Towne drilled well "Shark" 1 in Sacramento County near Lease PRC 8675.1. However, this well was a dry hole and on April 4, 2008, it

was plugged and abandoned in accordance with DOGGR regulations. As a result, Towne and ABA submitted on April 17, 2009, via email, a document entitled "Surrender of State Oil and Gas Lease" quitclaiming Lease PRC 8675.1.



SURRENDER OF STATE OIL AND GAS LEASE

State Oil and Gas Lease No. <u>PRC 8675.1</u> (Lease), covering certain State lands located in <u>Sacramento</u> County, State of California, was issued to Towne Exploration Company (Lessee) by the State of California, acting through the California State Lands Commission (State), on <u>April 17, 2006</u>, and was recorded in the Official Records of <u>Sacramento</u> County, at Book 20060517, Page 0122, on May 17, 2006.

Towne Exploration Company, a California limited partnership (Assignor) assigned forty percent of its undivided right, title and interest under State Oil and Gas Lease No. PRC 8675.1 to Capitol Oil Corporation (Assignee). At its meeting on May 10, 2007, the State Lands Commission approved said assignment effective June 1, 2007. It was recorded in the Official Records of Sacramento County at Document Number 200808261054 on August 26, 2008.

Capitol Oil Corporation (Assignor), as holder of an undivided forty percent (40%) interest, assigned all of its undivided right, title and interest under State Oil and Gas Lease No. PRC 8675.1 to ABA Energy Corporation (Assignee). At its meeting on May 5, 2008, the State Lands Commission approved said assignment effective June 1, 2008. It was recorded in the Official Records of Sacramento County, in Book 20080902, at Page 1221, on September 2, 2008.

Towne Exploration Company and ABA Energy Corporation (Lessees) are the present holders of the Lease.

Pursuant to the terms of State Oil and Gas Lease No. PRC 8675.1, the Lessee may make at any time a written quitclaim or relinquishment of all rights under this Lease or of any portion of the leased lands comprising a ten-acre parcel or multiple thereof in a compact form, or of any separate or distinct zone or geological horizon or portion thereof underlying a ten-acre parcel or multiple thereof in a compact form.

Acting in accordance with such terms, the **Lessees** do hereby release, remise and forever surrender and quitclaim unto the **State of California** all of their right, title and interest in and to the State lands held by virtue of State Oil and Gas Lease No. PRC 8675.1, which lands are described in the attached Exhibit A.
