**QUITCLAIM OF COMPENSATORY AGREEMENT EASEMENT 412.1**


Compensatory Agreement Easement 412.1 (Agreement), covering certain state lands underlying Whiskey Slough in the McDonald Island Gas Field in San Joaquin County, California, was issued March 1, 1940, between the State of California, acting through the California State Lands Commission (State) as first party, and Standard Oil Company of California as second party, and was amended by the parties effective June 1, 1950. Pacific Gas and Electric Company (PG&E) is the present holder of the Agreement as second party.

Paragraph 15 of the Agreement permits the parties to terminate the Agreement by mutual consent. Section 6804.1 of the Public Resources Code permits PG&E, as the holder of the Agreement, to quitclaim all of its rights under the Agreement. Acting pursuant to these provisions, PG&E releases, remises and forever quitclaims unto the State, all of its right, title and interest in and to the Agreement.
