**CONTINUATION OF RENT**

**LESSEE:**

GTE California, Inc.  
Right of Way Department  
11 South 4<sup>th</sup> Street, 2<sup>nd</sup> Floor  
Redlands, CA 92373

**AREA, LAND TYPE, AND LOCATION:**

0.30 acres, more or less, of State school land in a portion of Section 21, Township 1 South, Range 4 East SBM, near the city of Morongo Valley, San Bernardino.

**AUTHORIZED USE:**

Operation, use, and maintenance of existing overhead and underground telephone lines and power lines.

**LEASE TERM:**

49 years, beginning May 29, 1969.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease, and recommends that the rent be continued at \$100 per year, effective May 29, 2009.

**OTHER PERTINENT INFORMATION:**

1. On June 26, 1969, the Commission authorized a General Lease - Right of Way Use with General Telephone Company of California. On September 27, 1978, the Commission authorized an amendment of the lease to construct underground and aerial cables. In 1991, the Lessee's corporate name was since changed to GTE California, Inc. The lease will expire May 28, 2018.
2. GTE California, Inc., inspects its overhead power lines annually.

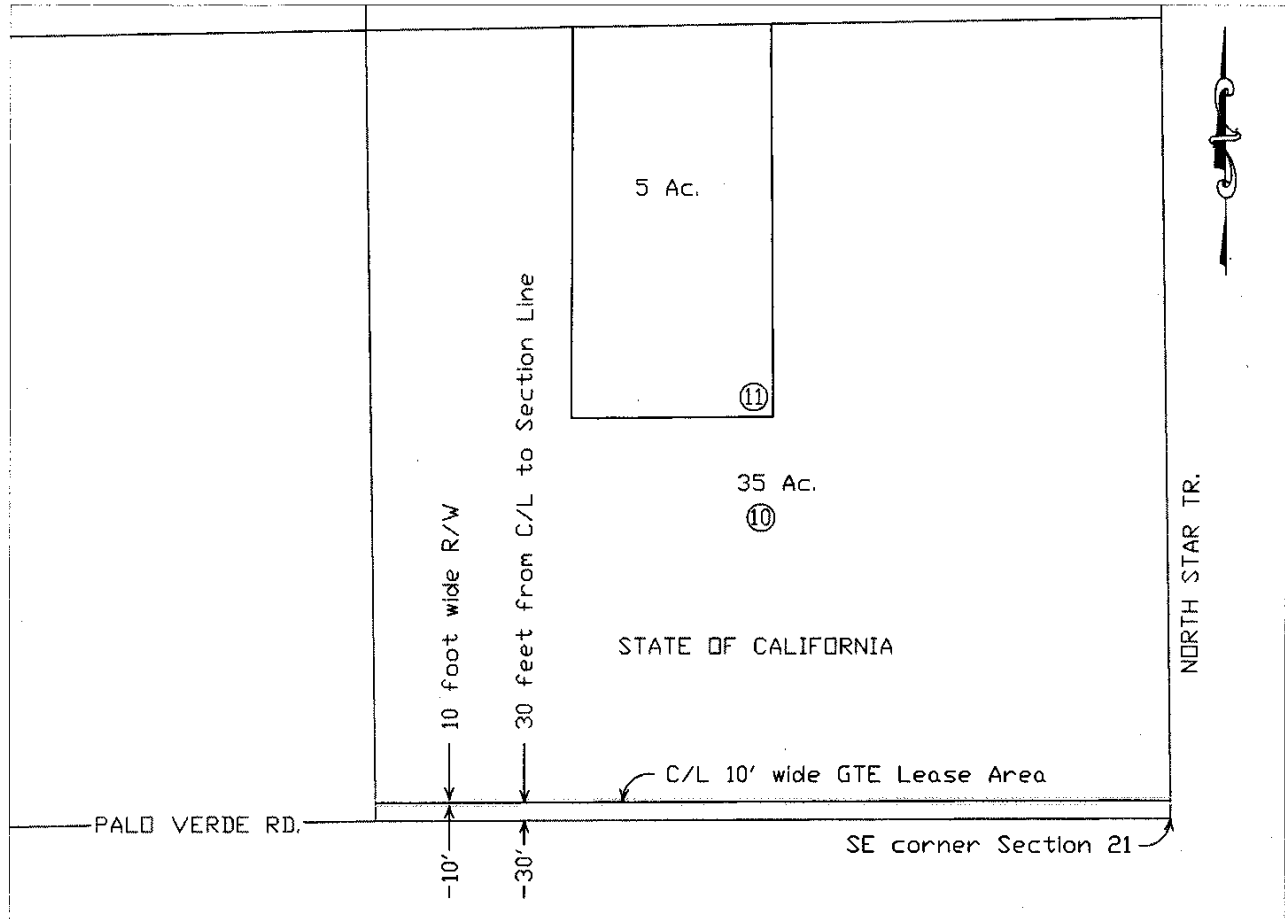

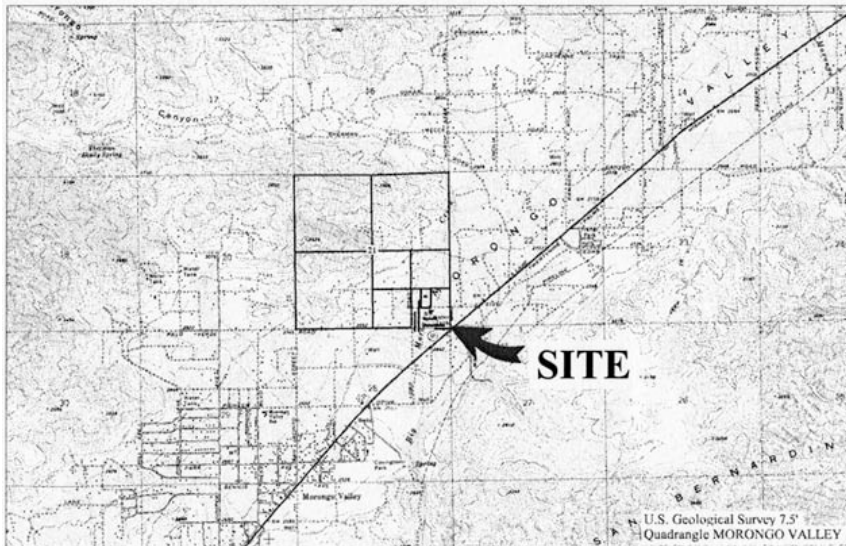
# SITE MAP
