BACKGROUND

Staff of the California State Lands Commission (SLC) has received several applications to lease school and/or lieu lands under the Commission's jurisdiction for the installation and operation of renewable energy projects. Staff anticipates that similar applications will continue to be received in the future, as utilities strive to meet the State's aggressive yet important renewable energy goals.

The California Energy Commission (CEC) has exclusive authority to certify thermal power plants with a generating capacity of 50 megawatts or more. Some project proposals received by SLC staff exceed this threshold; others do not. Approval of the proposed agreement will provide a helpful framework for staff of the SLC and CEC to perform their respective roles and share relevant information for all such project proposals, both above and below the CEC's exclusive jurisdictional threshold.

 Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 CCR § 15061), the staff has determined that this activity is

- exempt from the requirements of the CEQA because this activity is not a "project" as defined by the CEQA (PRC § 21065) and the State CEQA Guidelines (14 CCR § 15378).
