REVISION OF RENT

LESSEES:

Larry F. Gorham and Linda Gorham

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to Assessor's Parcel No. 142-0080-006, Grand Island, near the town of Walnut Grove, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing uncovered floating boat dock with slip, four pilings, and gangway as shown on Exhibit A.

LEASE TERM:

Ten years, beginning October 1, 2004.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$303 per year to \$381 per year, effective October 1, 2009.

OTHER PERTINENT INFORMATION:

1. On October 6, 2004, the Commission authorized a General Lease – Recreational Use to Larry F. Gorham and Linda Gorham. The lease authorized the construction, use, and maintenance of an uncovered floating boat dock and gangway. That lease will expire September 30, 2014.
2. The Lessees do not qualify for the rent-free use of the uncovered floating boat dock with slip, four pilings, and gangway because the littoral land is not improved with a single-family dwelling.

3. Riprap has been placed on the levee adjacent to the lease area by the Central Valley Flood Protection Board (CVFPB) and is authorized under Lease No. PRC 7203.9.

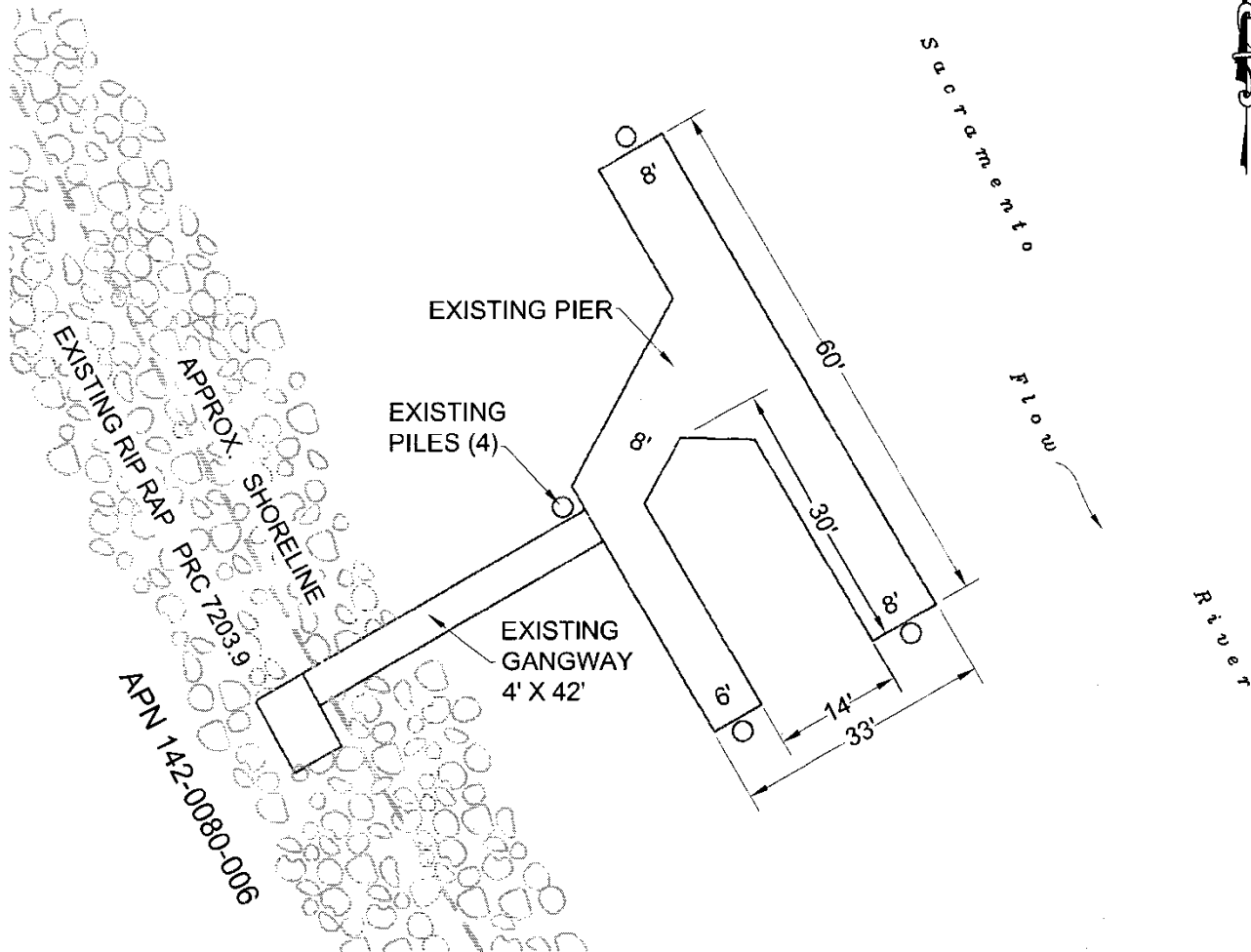
