#### DREDGING LEASE

#### LESSEE/APPLICANT:

Chevron Products Company 2400 Christie Street Eureka, CA 95501

#### AREA, LAND TYPE, AND LOCATION:

Legislatively granted tide and submerged lands, with minerals reserved to the State, located in Humboldt Bay, city of Eureka, Humboldt County.

#### **AUTHORIZED USE:**

Maintenance dredge a maximum of 2,300 cubic yards of material from an approximately 16,000 square foot wedge shaped area adjacent to the Chevron Marine Terminal pier and dock, with the dredged material to be disposed of at an approved upland disposal site.

#### **LEASE TERM**:

Five years, beginning April 6, 2010.

#### **CONSIDERATION:**

No monetary consideration will be charged. The dredged material may not be sold.

#### OTHER PERTINENT INFORMATION:

- 1. The proposed dredging will take place within tide and submerged lands legislatively granted to the city of Eureka, pursuant to Chapter 225, Statutes of 1945 and as amended, with minerals reserved to the State.
- 2. The deepwater channel of Humboldt Bay is periodically dredged by the U.S. Army Corp. of Engineers, but the Chevron Marine Terminal is outside the Channel. Chevron is now applying for a dredging lease to ensure safe navigation and operation of the marine terminal. The dredging will be performed by a small barge and clamshell crane dredger.

- 3. A Mitigated Negative Declaration (SCH#2004012096) was prepared by Humboldt Bay Harbor, Recreation, and Conservation District, and adopted on February 25, 2010 for this project. The California State Lands Commission's staff has reviewed such document.
- 4. A Mitigated Monitoring Program was adopted by the Humboldt Bay Harbor, Recreation, and Conservation District.
- 5 This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

Adopt the Mitigation Monitoring Program, as contained on filed in the Sacramento office of the California State Lands Commission.




#### **AUTHORIZATION:**

Authorize the issuance of a maintenance dredging lease to Chevron Products Company beginning April 6, 2010, for a term of five years, for dredging a maximum of 2,300 cubic yards from a wedge shaped area adjacent to the Chevron Marine Terminal pier and dock located in the city of Eureka, Humboldt County as shown on Exhibit A (for reference purposes only) and as described on Exhibit B attached and by this reference made a part hereof; dredged materials will be disposed of at an approved upland disposal site; such permitted activity is contingent upon applicant's compliance with applicable permits, recommendations, or limitations issued by Federal, State, and local governments; no royalty to be charged; as the project will result in a public benefit dredged material may not be sold.

#### LAND DESCRIPTION

A parcel of submerged land situate in the bed of the Humboldt Bay, Humboldt County, State of California, lying adjacent to Section 33, Fractional Township 5 North, Range 1 West, Humboldt Meridian as shown on Official U.S. Government Plat approved October 22, 1890, described as follows:

BEGINNING at a point having CCS83, Zone 1 coordinates: Northing (y) = 2174042.22 feet and Easting (x) = 5953361.69 feet which bears North  $81^{\circ}06'46''$  East 6851.21 feet from NGS monument PID LV0744 having CCS83, Zone 1 coordinates: Northing (y) = 2172983.76 feet and Easting (x) = 5946592.74 feet;

thence from said point of beginning the following five (5) courses:

- (1) North 63°16'00" West 110.42 feet,
- (2) North 25°43'37" East 68.77 feet,
- (3) North 45°20′14" East 177.96 feet,
- (4) North 39°59'23" East 234.85 feet, and
- (5) South 26°36'38" West 466.00 feet to the point of beginning.
