REVISION OF RENT

LESSEE:

Santa Fe Aggregates, Inc.
P.O. Box 3042
Modesto, CA 95353

AREA, LAND TYPE, AND LOCATION:

12.32 acres, more or less, of sovereign land located in the historic bed of the Tuolumne River, near Waterford, Stanislaus County.

AUTHORIZED USE:

Stockpiling of processed and unprocessed gravel, use and storage of related equipment, and a bridge right-of-way crossing.

LEASE TERM:

25 years, beginning December 30, 1992.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that the rent be revised from \$5,625 per year to \$6,086 per year, effective December 30, 2011.

OTHER PERTINENT INFORMATION:

1. On November 30, 1977, the Commission authorized a 15-year General Lease–Industrial Use to M.J. Ruddy, Jr., dba Santa Fe Rock and Sand, with a 10-year renewal option. On December 17, 1992, the Commission terminated the lease and issued a new 25-year lease to M.J. Ruddy & Son, Inc. beginning December 30, 1992.
2. On March 22, 1995, the articles of incorporation for M.J. Ruddy and Son, Inc. were amended to change the name of the corporation to Santa Fe Aggregates, Inc. No Commission action was required.

3. The lease premises include a parcel in the abandoned channel of the Tuolumne River and a parcel in the present channel of the river. The stockpiling and equipment storage is located on the abandoned channel and the right-of-way crossing includes a concrete bridge used for equipment to cross the present channel.

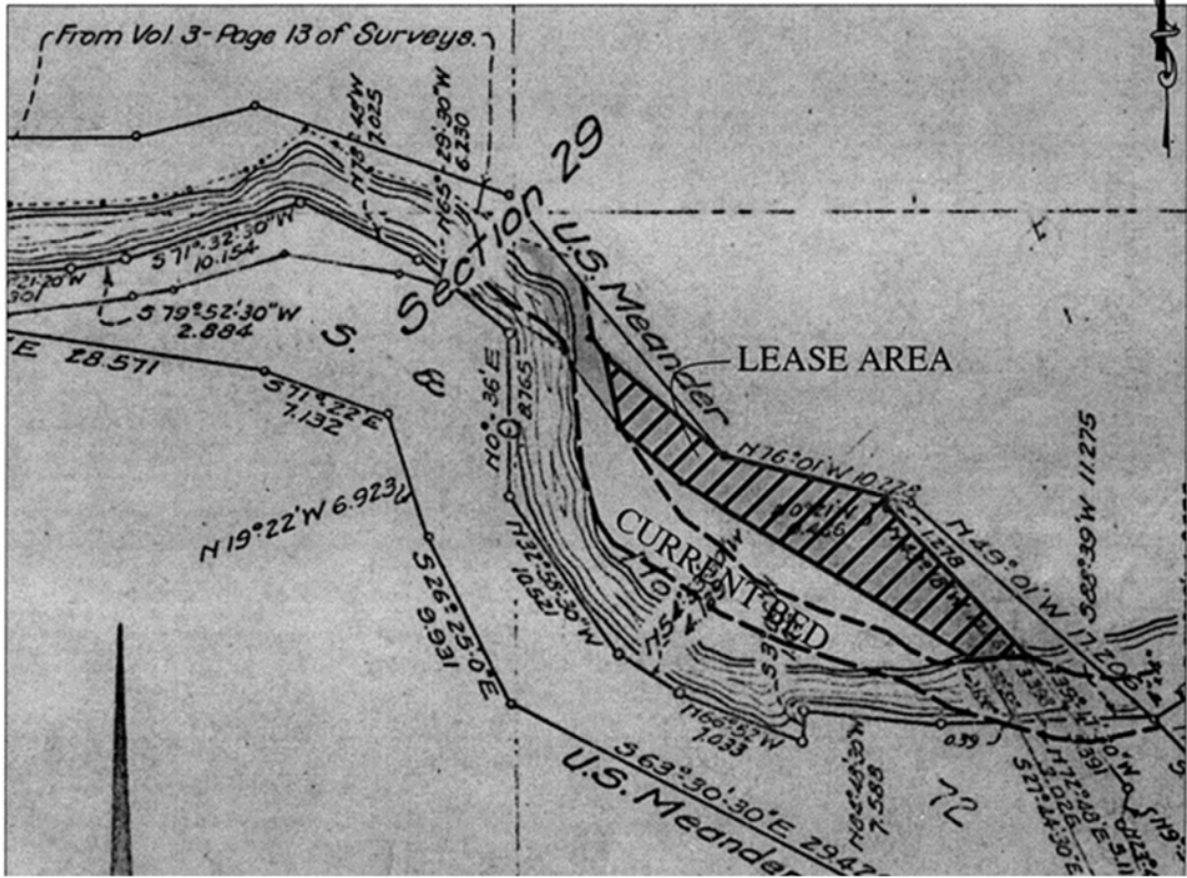

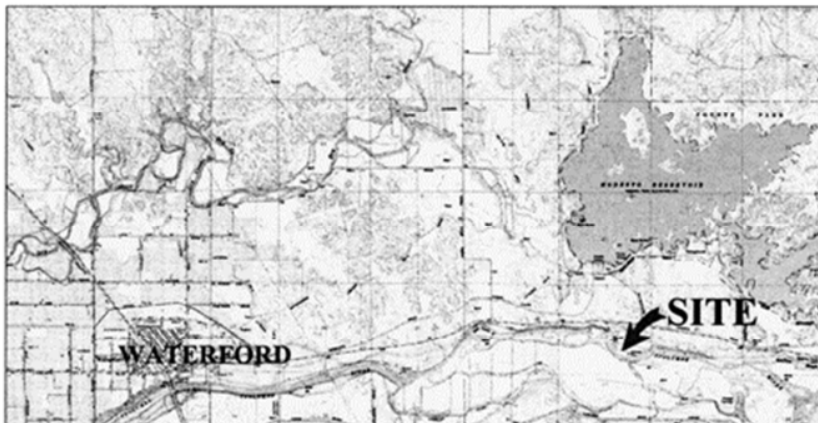
SITE
