RESCISSION OF COMMISSION AUTHORIZATION FOR AN AMENDMENT OF GENERAL LEASE – RIGHT-OF-WAY USE

LESSEE:

North Baja Pipeline, LLC 534 East Spokane Falls Boulevard Spokane, WA 99202

AREA, LAND TYPE, AND LOCATION:

1.15 acres, more or less, of State school land located in a portion of Section 16, Township 12 South, Range 20 East, SBM, near State Highway 78, Imperial County.

AUTHORIZED USE:

Construction, use and maintenance of an additional 48-inch diameter natural gas pipeline as shown on the attached Exhibit A.

LEASE TERM:

20 years, beginning February 1, 2002.

CONSIDERATION:

\$1,551 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance: Liability insurance with combined single limit coverage of not less than \$10,000,000.

Bond: \$10,000.

OTHER PERTINENT INFORMATION:

1. Applicant has the right to use the land adjoining the lease premises.

- 2. On January 20, 2002, the Commission authorized a 20-year General Lease Right-of-Way Use with North Baja Pipeline, LLC for the construction of a 30-inch diameter steel natural gas pipeline. The lease will expire on January 31, 2022.
- 3. On July 13, 2007, the Commission authorized an amendment to the lease to expand the lease area for the construction of an additional 48-inch diameter natural gas pipeline. The amendment was never executed. The Lessee informed Commission staff that they do not intend to move forward any time in the near future with Phase 2 of the North Baja expansion project which included the construction of the additional 48-inch pipeline authorized in the amendment. Staff is now recommending the rescission of the Commission authorization for the amendment.
- 4. Since the amendment was never executed, rent has remained at the preamendment rent level of \$655.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14,California Code of Regulations, section15060 (c)(3)], the staff has determined this activity is not subject to the provisions of CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, sections 15060 (c)(3) and 15378.



- Thence N21°52'50"E, 272.85 feet to the beginning of a tangent curve concave to the southeast having a radius of 4730 feet; thence northeasterly 649.61 feet along said curve through a central angle of 7°52'08";

Thence N29°44'58"E, 127.45 feet to the north line of said Section 16;

Thence S88°42'58"W, 58.34 feet along said north section line and the north line of this parcel, to the POINT OF BEGINNING.
