**CONSIDER THE TERMINATION OF  
STATE OIL AND GAS LEASE PRC 1341.1,  
HUNTINGTON BEACH OIL AND GAS FIELD  
(OFFSHORE AREA),  
ORANGE COUNTY**

**AREA, LAND TYPE AND LOCATION:**

Offshore Huntington Beach, California, see Exhibit A (attached hereto) for land description.

**BACKGROUND:**

State Oil and Gas Lease PRC 1341.1 (Lease PRC 1341.1) was originally issued as "Agreement for Easement No. 336 Huntington Beach" by the Director of Finance on March 1, 1934 to W.K. Company, et al. This agreement was one of approximately 80 such "one-well trespass easement" agreements that were entered into in 1933 and 1934. The well associated with Lease PRC 1341.1 was plugged and abandoned on July 15, 1974.

Lease PRC 1341.1 Paragraph 2 requires the Lessee to pay the State annually in advance, as rental, the sum of fifty dollars (\$50.00) and Paragraph 13 requires the Lessee to maintain a good and sufficient bond in the penal sum of two thousand dollars (\$2,000.00) to guarantee the faithful performance by the Lessee of the terms, covenants and conditions of the Lease. The last annual rental payment received for this lease was in March 1998.

California State Lands Commission (CSLC) staff sent correspondence dated February 18, 1999 to Ms. Barbara Stone, the Trustee for Dorothy F. Morton

owner of W.K. Company, requesting payment for the 1999 annual rental due. Ms. Stone sent a reply stating that the Estate sold the lease to a Mr. Richard Kelter. Attempts to contact and bill Mr. Kelter at the address given by Ms. Stone have gone unanswered. There has been no application submitted by Mr. Kelter or any other party to request Commission consideration to assign the lease.

Because the rental and bond requirements of Lease PRC 1341.1 have not been met, staff recommends that the California State Lands Commission terminate Lease PRC 1341.1 for lack of rental payments and for having an expired surety bond.

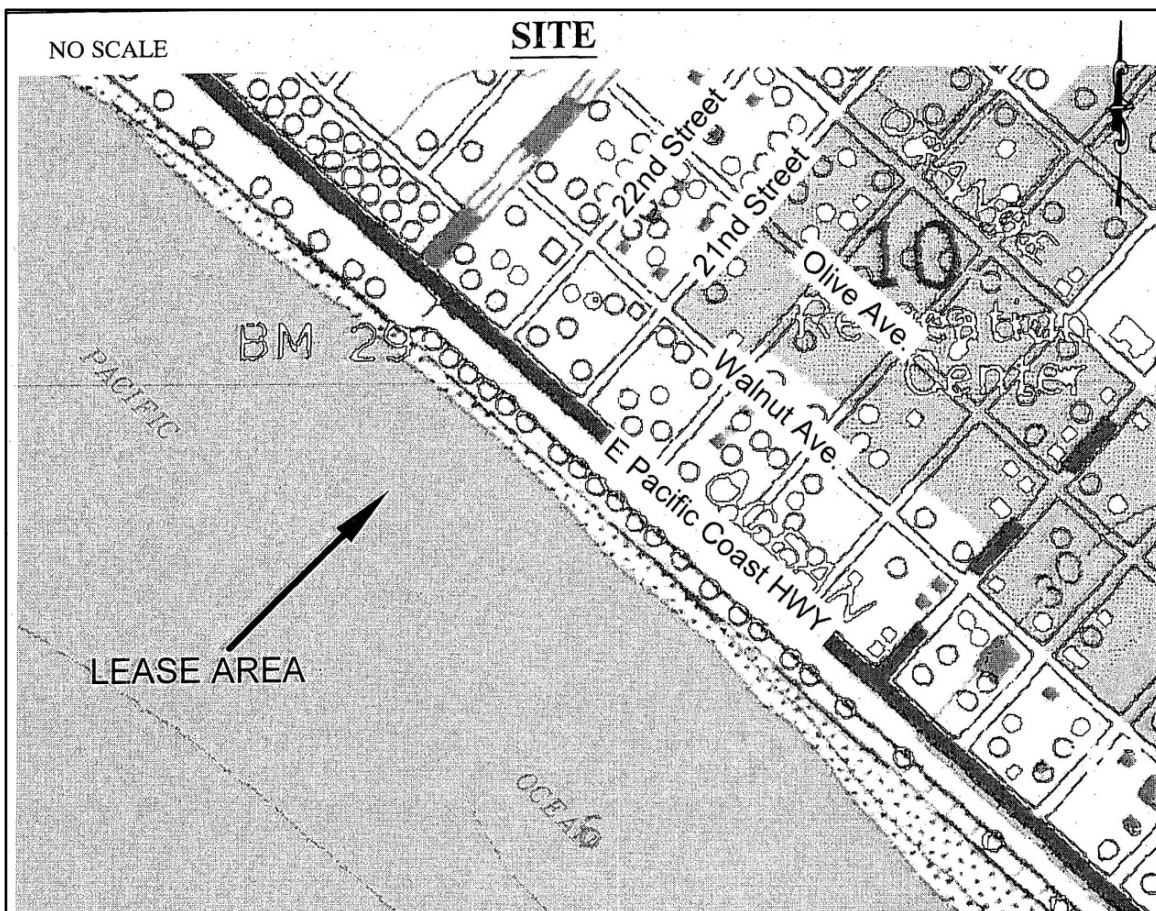
### **LAND DESCRIPTION**

A cylindrical area 24 inches in diameter extending throughout the full length, course and distance of well "W.K." No. 1 in so far as the same is in lands of the State extending seaward of the ordinary high water mark of the Pacific Ocean. The centerline of the cylindrical area is the centerline of the well as disclosed by the survey or plats thereof filed heretofore with the Division of Oil and Gas of the Department of Natural Resources.

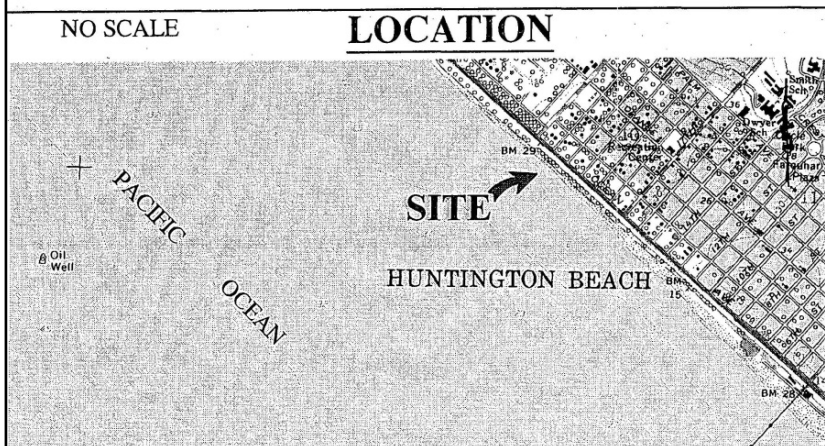
The surface location of well "W.K." No. 1, for which an easement is granted hereby, and the producing facilities are located on Lots Fourteen (14), Sixteen (16), Eighteen (18) and Twenty (20) in Block Two Hundred Twenty-one (221) of "Huntington Beach, Seventeenth St. Section", as shown on a Map recorded in Book 4, Page 10 of Miscellaneous Maps, records of Orange County, California.
