**RECORD OF ACTION TAKEN BY THE  
CALIFORNIA STATE LANDS COMMISSION  
MEETING OF AUGUST 14, 2012, ADJOURNED AND  
RECONVENED AUGUST 20, 2012**

Chair Alternate Alan Gordon called the August 14, 2012 meeting of the California State Lands Commission to order at 9:00 A.M. at the Secretary of State's Auditorium, 1500 11<sup>th</sup> Street, Sacramento, California 95814; also present were Commissioner Gavin Newsom and Commissioner Alternate Pedro Reyes.

The Minutes of the June 7, 2012 special meeting were approved by a vote of 2-0 (Gordon and Reyes voting).

**EXECUTIVE OFFICER'S REPORT**

Executive Officer Curtis Fossum updated the Commission on the following items:

- The Commission's revenues for fiscal year 2010/11 exceeded \$529 million with over \$497 million deposited in the State's General Fund – these numbers reflect a \$100 million increase over the prior year.
- Staff participated in a workshop with the Tahoe Lakefront Owner's Association on June 29<sup>th</sup> at the Granlibakken Conference Center. Approximately 200 persons attended. Presentations were made by the Association's Executive Director and Commission staff followed by a question and answer period.
- Two state audits are being conducted involving the Oil Spill Prevention and Administration Fund. One audit by the Bureau of State Audits was due on August 14<sup>th</sup> the other by the Department of Finance is just beginning. These audits are essential to gain stakeholder and legislative support to maintain funding for the oil spill prevention programs of the Commission.
- Progress on the Commission's boundary staff's mapping of state property interests in the San Joaquin River in conjunction with the restoration project there was reported.
- Marina Voskanian was appointed as Chief of the Mineral Resources Management Division.
- Sheri Pemberton was appointed as Chief of the External Affairs Division.

**CONSENT CALENDAR**

Consent Items C45, C46, C85, C93, and C94 were removed from the agenda, to be heard at a later date. Consent Items C01-C44, C47-50, C52-C84 and C86-C92 were approved as presented by a vote of 3-0. Consent Items C95-C101 were approved as presented, by a vote of 2-0 (Newsom and Gordon). Consent Item C51 was moved to the Regular Calendar.

### INFORMATIONAL

**ITEM 102:** Staff report on the monitoring of possible subsidence, Long Beach Unit, Wilmington Oil Field, Los Angeles County. The item was informational – no staff presentation and no vote required.

### REGULAR CALENDAR

**ITEM 51:** A staff presentation was made to the Commission for consideration of a new general lease, commercial use, for a restaurant on a vessel in Burlingame. The Commission listened to testimony from interested parties and discussed the matter.

Item 51 was deferred, to be considered at a future meeting.

**ITEM 106:** A staff presentation was made recommending that the Commission consider an application for a general lease, recreational use, of sovereign land located in Lake Take, for an existing joint-use pier, boathouse and boat lift. The Commission listened to testimony from interested parties and discussed the matter.

Item 106 was deferred, to be considered at a future meeting.

**ITEM 107:** A staff presentation was made recommending that the Commission consider an application for a general lease, recreation use, of sovereign land located at Lake Tahoe, for two existing mooring buoys.

Item 107 was approved as presented by a vote of 3-0.

**ITEM 103:** A staff presentation was made to the Commission for consideration of a Land Exchange Agreement between the Commission and the Port of San Francisco, involving parcels of land located within Seawall Lot 351 and the 8 Washington Street property. The Commission listened to testimony from interested parties.

Item 103 was approved as presented by a vote of 2-0 (Newsom and Gordon).

**ITEM 105:** No staff presentation was made.

Item 105 was deferred, to be considered at a future meeting.

**ITEM 104:** A staff presentation was made to the Commission for consideration of the certification of a Final Environmental Impact Report, adoption of a Mitigation Monitoring Program, CEQA Findings, a Statement of Overriding Considerations and issuance of a permit to Pacific Gas and Electric Company to conduct a 3D geophysical survey employing the use of air guns and hydrophones off the Coast of San Luis Obispo County.

Item 104 – Following discussion and testimony from interested parties, the Commission on August 14, 2012 approved certification of the Final EIR, by a 2-0 vote (Garland and Reyes). On August 20, 2012 following additional staff presentation, testimony from interested parties and Commission discussion, the Commission by a 2-0 vote (Gordon and Reyes) adopted the Mitigation Monitoring Program, CEQA Findings for a Modified Timing Three-Loop Configuration project, Statement of Overriding Considerations for a Modified Timing Three-Loop Configuration project and authorized issuance of a Geophysical Permit for the Modified Timing Three-Loop Configuration project to conduct a 3D seismic survey off the Coast of San Luis Obispo County.

The Commission meeting public session was adjourned at 4:15 P.M.
