REVISION OF RENT

LESSEES:

Gene H. Colver and Kathy C. Colver

AREA, LAND TYPE, AND LOCATION:

Sovereign land located in the Sacramento River, adjacent to 14909 State Highway 160, Walnut Grove, Sacramento County.

AUTHORIZED USE:

Continued operation, use, and maintenance of an existing commercial marina, known as Deckhands.

LEASE TERM:

20 years, beginning June 1, 2006.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that rent be revised from \$1,275 per year to \$1,460 per year, effective June 1, 2013.

OTHER PERTINENT INFORMATION:

1. On June 26, 2006, the Commission authorized a General Lease – Commercial Use to Gene H. Colver and Kathy C. Colver for an existing commercial marina consisting of an accommodation dock, fixed walkway, and pilings. The lease will expire on May 31, 2026.
2. Staff conducted the rent review called for in the lease and recommends that the rent be increased, effective June 1, 2013.
3. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and

is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

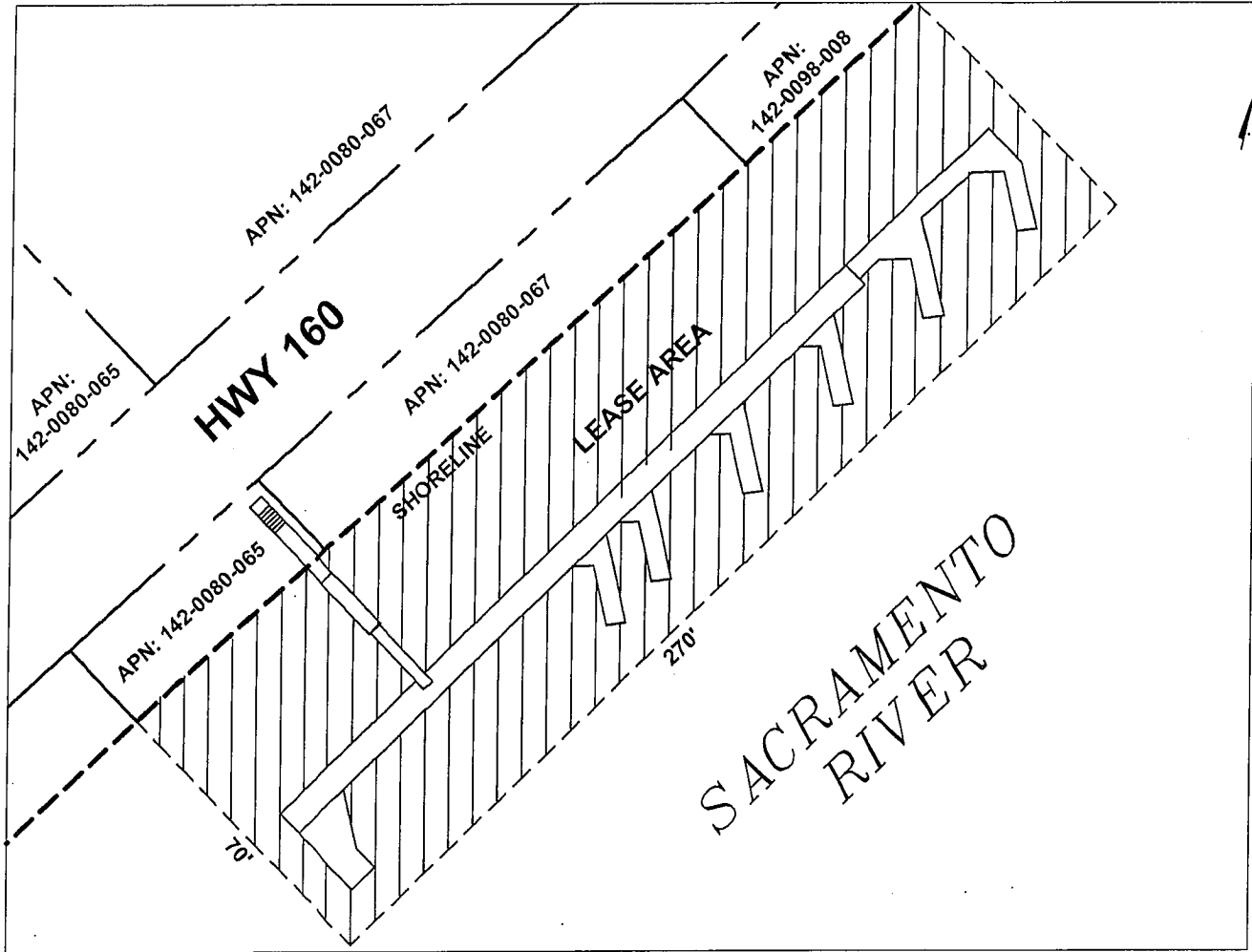

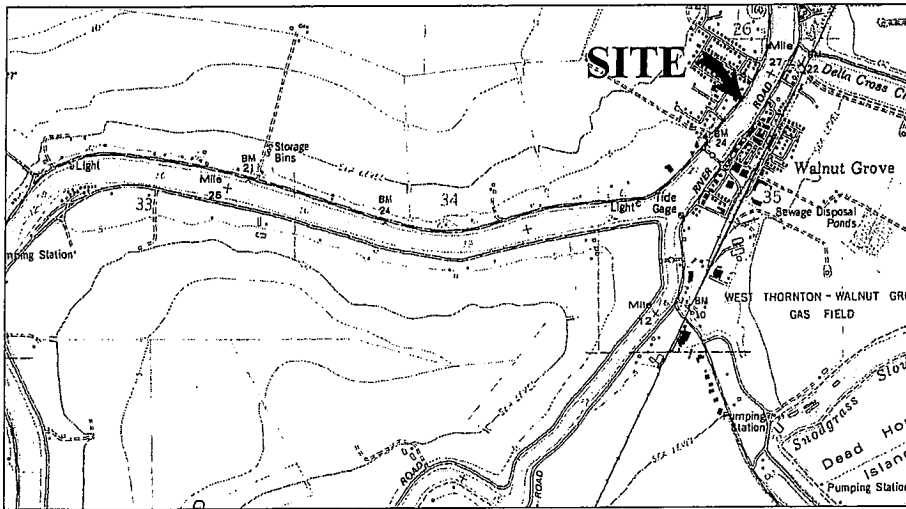
SITE
