ASSIGNMENT OF LEASE

LESSEE/ASSIGNOR:

Matthew Gnagy

APPLICANTS/ASSIGNEES:

Steve Chadaris and Jannine Chadaris

AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Sacramento River, adjacent to 10005 Garden Highway, near Verona, Sutter County.

AUTHORIZED USE:

Continued use and maintenance of an existing single-berth covered dock, four pilings, gangway, two electrical boxes, water line and bank protection.

LEASE TERM:

10 years, beginning December 28, 2009.

CONSIDERATION:

Covered Single-Berth Floating Boat Dock, Four Pilings, Gangway, Two Electrical Boxes, and Water Line: No monetary consideration pursuant to Public Resources Code section 6503.5.

Bank Protection: The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest

SPECIFIC LEASE PROVISIONS:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

OTHER PERTINENT INFORMATION:

1. Assignees own the upland adjoining the lease premises.

CALENDAR ITEM NO. **C33** (CONT'D)

2. On December 10, 2010, the Commission authorized a General Lease-Recreational and Protective Structure Use with Matthew Gnagy, for an existing single-berth covered dock, four pilings, gangway, two electrical boxes, water line and bank protection. That lease will expire on December 27, 2019. On August 2, 2013, the upland parcel was deeded to Steve Chadaris and Jannine Chadaris. The Applicants are now applying for an assignment of the lease.
3. The staff recommends that the Commission find that the subject lease assignment does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.

CEQA FINDING:

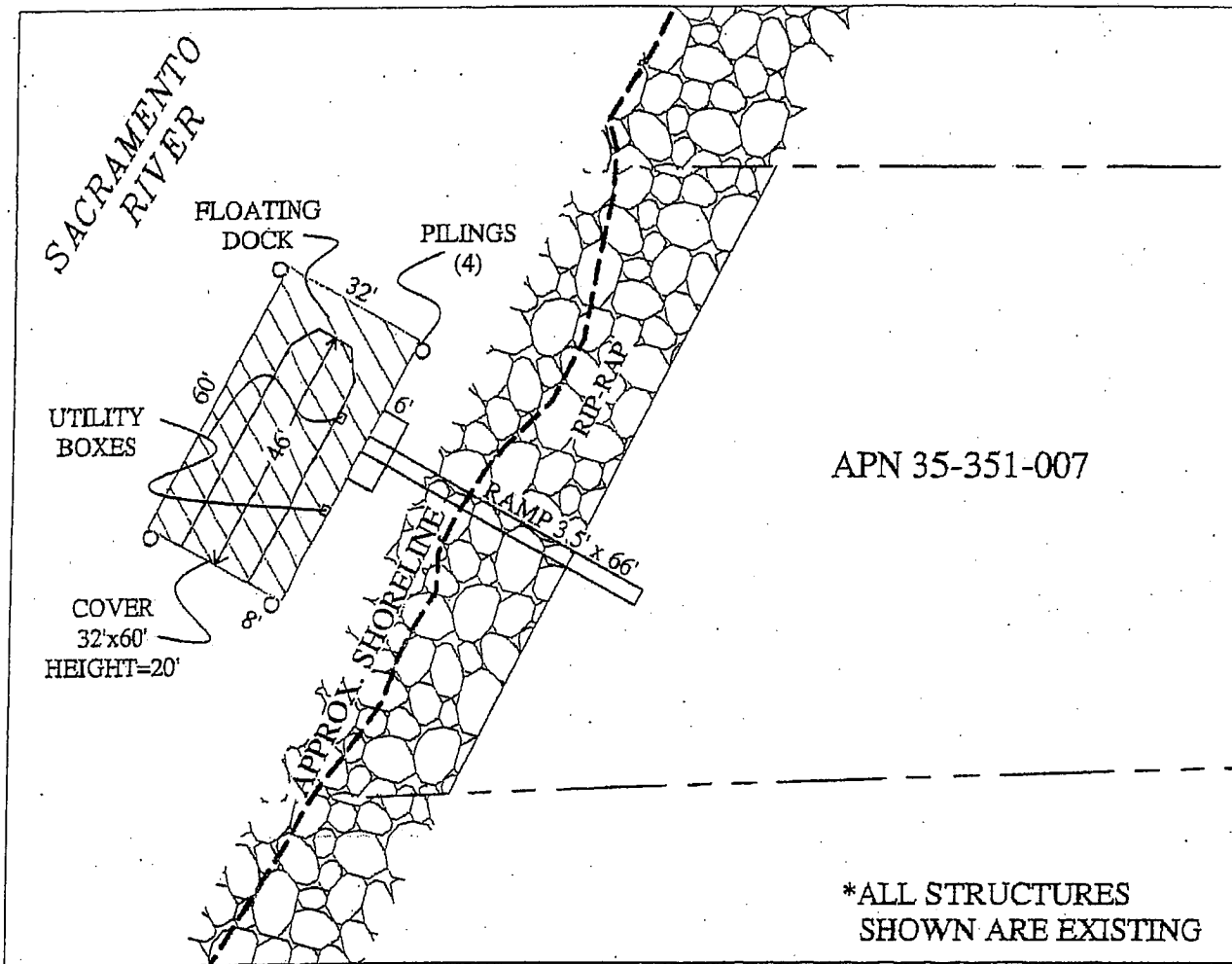

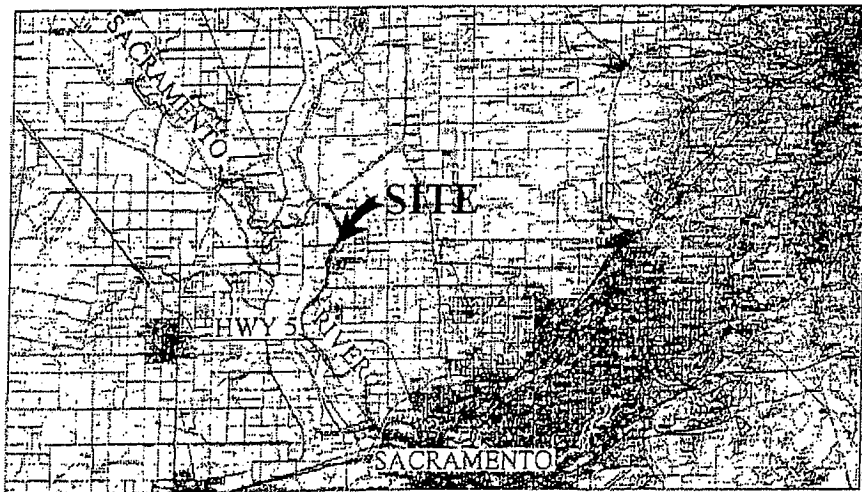
SITE
