REVISION OF RENT

LESSEE:

Sacramento Yacht Club P.O. Box 1245 West Sacramento, CA 95691

LAND TYPE AND LOCATION:

5.203 acres, more or less, of sovereign land in the Sacramento River, city of West Sacramento, Yolo County

AUTHORIZED USE:

The continued use and maintenance of a private yacht club, which includes 90 individual slips, a debris diverter, 400 feet of guest dockage, 400 feet of side-tie dockage, and two sewage pumpout stations.

LEASE TERM:

25 years, beginning September 23, 1992

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$18,000 per year to \$19,582 per year, effective September 23, 2014.

OTHER PERTINENT INFORMATION:

- 1. Lessee has the right to use the upland adjacent to the Lease Premises.
- 2. On September 23, 1992, the Commission authorized a General Lease Recreational Use to the Sacramento Yacht Club, for the reconstruction/expansion, use, and maintenance of a private yacht club. That lease will expire on September 22, 2017
- 3. Staff conducted the rent review called for in the lease and recommends the rent increase.

4. Staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).


