### **REVISION OF RENT**

#### LESSEE:

San Diego Gas & Electric Company 8335 Century Park Court – CP11D San Diego, CA 92123

## AREA, LAND TYPE, AND LOCATION:

0.06 acre, more or less, of State school land in a portion of Section 36, Township 15 South, Range 3 East, SBM, in the Cleveland National Forest, San Diego County.

#### **AUTHORIZED USE:**

Operation, use, and maintenance of an existing 69 kilovolt (kV) power line.

#### LEASE TERM:

49 years, beginning January 1, 1970.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease, and recommends that the rent be revised from \$100 per year to \$450 per year, effective January 1, 2015.

### OTHER PERTINENT INFORMATION:

- On May 28, 1970, the Commission authorized a General Lease Right-of-Way Use with San Diego Gas & Electric Company. That lease will expire on December 31, 2018.
- 2. The power line which is used to transport electricity is inspected annually. The inspections are current and no violations have been reported.
- 3. As of July 1, 2014, the minimum annual rental amount for a General Lease Right-of-Way Use is \$450 pursuant to California Code of Regulations, Title 2, section 2003, subdivision (b)(3).

- 4. Staff conducted the rent review called for in the lease and recommends a rent increase to \$450 per year.
- 5. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.




#### **CEQA FINDING:**
