GENERAL LEASE - RECREATIONAL USE

APPLICANTS:

Isaac Goff and Renee Goff, Trustees of the Isaac Goff and Renee Goff Revocable Intervivos Trust Agreement dated 4/29/92

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Donner Lake, adjacent to 15873 Donner Pass Road, near the town of Truckee, Nevada County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier previously authorized by the Commission; and use and maintenance of two existing jet ski lifts not previously authorized by the Commission.

LEASE TERM:

10 years, beginning December 21, 2014.

CONSIDERATION:

\$183 per year, with an annual Consumer Price Index (CPI) adjustment.

SPECIFIC LEASE PROVISIONS:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

OTHER PERTINENT INFORMATION:

- 1. Applicants own the upland adjoining the lease premises.
- 2. On November 21, 2006, the Commission authorized a 10-year Recreational Pier Lease to Isaac Goff and Renee Goff, Trustees of the Isaac Goff and Renee Goff Revocable Intervivos Trust Agreement dated 4/29/92. That lease will expire on December 20, 2014. The Applicants are now applying for a General Lease Recreational Use.

- 3. The Applicants' two jet ski lifts have been in Donner Lake for many years, but were not previously authorized by the Commission. Staff recommends bringing the existing two jet ski lifts under lease.
- 4. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

Authorize issuance of a General Lease – Recreational Use to Isaac Goff and Renee Goff, Trustees of the Isaac Goff and Renee Goff Revocable Intervivos Trust Agreement dated 4/29/92, beginning December 21, 2014,

for a term of 10 years, for the continued use and maintenance of an existing pier previously authorized by the Commission; and use and maintenance of two existing jet ski lifts not previously authorized by the Commission as described in Exhibit A and shown on Exhibit B (for reference purposes only) attached and by this reference made a part hereof; annual rent in the amount of \$183, with an annual Consumer Price Index adjustment; and liability insurance in an amount no less than \$1,000,000 per occurrence.






