**REVISION OF RENT**

**LESSEE:**

Donald G. Goodwin

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in Huntington Harbour, adjacent to 16492 Somerset Lane, city of Huntington Beach, Orange County.

**AUTHORIZED USE:**

The continued use and maintenance of an existing boat dock, access ramp, cantilevered deck extending no more than five feet waterward of the bulkhead and repair of an existing bulkhead.

**LEASE TERM:**

10 years, beginning June 28, 2010.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$1,103 per year to \$1,323 per year, effective June 28, 2015.

**OTHER PERTINENT INFORMATION:**

1. On June 28, 2010, the Commission authorized a General Lease – Recreational and Protective Structure Use to Donald G. Goodwin for the continued use and maintenance of a boat dock, access ramp, cantilevered deck and for repairs to an existing bulkhead. The lease will expire on June 27, 2020.
2. This authorization is for a revision of rent only. Staff conducted the rent review called for in the Lease and recommends that the annual rent be increased.
3. The staff recommends that the Commission find that the subject revision

of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.
