GENERAL LEASE - RECREATIONAL USE

APPLICANT:

Moana Beach Property Owners Association, Inc.

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to Assessor's Parcel No. 098-191-011, Moana Circle, near Homewood, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier.

LEASE TERM:

10 years, beginning October 26, 2014.

CONSIDERATION:

\$822 per year, with an annual Consumer Price Index adjustment.

SPECIFIC LEASE PROVISIONS:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

OTHER PERTINENT INFORMATION:

- 1. The Applicant owns the upland adjoining the lease premises.
- On April 26, 2005, the Commission authorized a 10-year General Lease -Recreational Use to Moana Beach Property Owners Association, Inc. That lease expired on October 25, 2014. The Applicant is now applying for a General Lease – Recreational Use.
- 3. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

AUTHORIZATION:

Authorize issuance of a General Lease – Recreational Use to Moana Beach Property Owners Association, Inc. beginning October 26, 2014, for a term of 10 years, for the continued use and maintenance of an existing pier as described in Exhibit A and shown on Exhibit B (for reference purposes only) attached and by this reference made a part hereof; annual rent in the amount of \$822, with an annual Consumer Price Index adjustment; and liability insurance with coverage in an amount no less than \$1,000,000 per occurrence.

TOGETHER WITH any applicable Impact Area(s).


EXCEPTING THEREFROM any portion lying landward of elevation 6223 feet LTD on the shoreline of said Lake Tahoe.




