# RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF JUNE 29, 2015

Chair Kevin Schmidt called the meeting of the California State Lands Commission to order at 9:57 A.M. at the Holiday Inn Capitol Plaza, California Room, Sacramento, California 95814; also present were Commissioner Betty T. Yee and Commissioner Alternate Eraina Ortega.

(The State Lands Commission adjourned into closed session from 10:00 A.M. to 10:19 A.M., then resumed open session at 10:22 A.M.)

The Minutes of the April 23, 2015 Meeting were approved by a vote of 3-0 (Schmidt-Yes; Yee-Yes; Ortega-Yes).

# **CONSENT CALENDAR**

**ITEM 95:** A staff presentation was made to the Commission on the status of the Commission's Draft Strategic Plan.

Item 95 – was informational – no vote required.

**ITEM 96:** A presentation was made to the Commission to consider supporting AB 1323, authored by Assemblymember Frazier that would facilitate the removal and disposal of dilapidated vessels that are unseaworthy and incapable of being made seaworthy from state waterways, public beaches, and state tidelands or submerged lands.

Item 96 – was approved as presented by a 2-0 vote (Schmidt-Yes; Yee-Yes; Ortega-Abstained).

**ITEM 97:** A presentation was made to the Commission to consider supporting AB 888, authored by Assemblymember Bloom that would prohibit the sale of personal care products in California that contain plastic microbeads on or after January 1, 2020.

#### RECORD OF ACTION CONTINUED

Item 97 – was approved as presented by a vote of 2-0 (Schmidt-Yes; Yee-Yes; Ortega-Abstained).

ITEM C84: A presentation was made to the Commission to consider the authorization of the sale and issuance of a patent to the United States of America for 2,563 acres of State school lands and State indemnity school lands located west and south of the Marine Corps Air Ground Combat to the United States of America in San Bernardino County; and authorization to enter into a memorandum of agreement with United States of America for future access to explore and develop the mineral estate.

Item C84 – was approved as presented by a vote of 2-0 (Schmidt-Abstained; Baker-Yes; Ortega-Yes).

**ITEM 98:** A staff presentation was made to consider the application for a General Lease – Commercial Use, of sovereign land located at Pebbly Beach, Santa Catalina Island.

Item 98 – was approved as presented by a vote of 2-0 (Schmidt-Abstained; Baker-Yes; Ortega-Yes).

#### **EXECUTIVE OFFICER'S REPORT**

Executive Officer Jennifer Lucchesi updated the Commission on the following items:

- Commission staff met with representatives from Martins Beach, LLC on May 12<sup>th</sup> to continue negotiations for an acquisition of a public access easement or right-of-way. Staff is in the process of preparing an appraisal to be used in the negotiations.
- Commission staff sent a letter to the City of Newport Beach on June 16<sup>th</sup> requesting the opportunity to discuss with the City their proposed modification to the mooring permit policies and fee structures for facilities located on legislatively granted tideland and submerged lands.
- A staff presentation was made to the Commission highlighting features on the Commission's proposed new website. Some of the new features discussed include: a redesign of all the pages and revised tab structure; added content about land classifications, water boundaries, and land titles; and hard-to find historical information.
- A staff presentation was made to the Commission to provide an update on the Refugio oil spill that took place on May 19<sup>th</sup>, 2015, near Refugio Beach in Santa Barbara County.
