AMENDMENT OF LEASE

LESSEE:

Michael F. Denton, Sr.

AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Colorado River, adjacent to 1178 Beach Drive, City of Needles, San Bernardino County.

AUTHORIZED USE:

Use and maintenance of an existing stairway with aluminum railing, two sun decks with aluminum railing, shower, and riprap bankline.

LEASE TERM:

10 years, beginning August 23, 2013.

CONSIDERATION:

Two Sun Decks with Aluminum Railing and a Shower: Annual rent in the amount of \$143 per year, with the State reserving the right to fix a different rent periodically during the term of the lease, as provided in the lease.

Stairway with Aluminum Railing and Riprap Bankline: Public use and benefit, with the State reserving the right to set a monetary consideration if it is determined to be in the best interests of the State.

PROPOSED AMENDMENT:

Amend the Lease to:

- 1. Allow for the removal of the existing retractable stairway; and for the construction, use, and maintenance of two aluminum stairways with railing, an aluminum gangway with railing, and a floating walkway and boat dock;
- 2. Revise the annual rent from \$143 to \$331 per year, effective August 23, 2016, to include the new improvements;

- 3. Include Special Provisions related to the construction of the improvements; and
- 4. Replace Exhibit A, Land Description, and Exhibit B, Site and Location Map with new Exhibits A and B.

All other terms and conditions of the lease shall remain in effect without amendment.

OTHER PERTINENT INFORMATION:

- 1. Lessee owns the upland adjoining the lease premises.
- 2. On September 20, 2013, the Commission authorized a General Lease Recreational and Protective Structure Use to Michael F. Denton, Sr. and Merrie N. Denton, for an existing stairway with aluminum railing, two sun decks with aluminum railings, a shower, and riprap bankline. Merrie N. Denton passed away before the lease was executed and was never a signatory on the lease.
- 3. On December 5, 2012, the Commission authorized staff to resume processing applications for boat docks in the Rio Buena Vista community on a case-by-case basis consistent with the Commission's practices for leasing on inland waterways and the public trust needs in the area. The Lessee is now applying to amend the lease to remove the retractable stairs and construct two aluminum stairways with railings, an aluminum gangway with railing, and a floating walkway and boat dock. Commission staff has evaluated the proposed improvements, and believes they are consistent with the Commission's direction, and therefore recommends approval. To accommodate these improvements, the lease area will be expanded to include an area identified as "Parcel 2" within Exhibits A and B.
- 4. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; California Code of Regulations, Title 2, section 2905, subdivision (c)(1).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

It is recommended that the Commission:

CEQA FINDING:

Find that the activity is exempt from the requirements of CEQA pursuant to California Code of Regulations, Title 14, section 15061 as a categorically exempt project, Class 3, New Construction of Small Structures; California Code of Regulations, Title 2, section 2905, subdivision (c)(1).

SIGNIFICANT LANDS INVENTORY FINDING:

Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code section 6370 et seq.

AUTHORIZATION:

Authorize the amendment of Lease No. PRC 9086.1, a General Lease - Recreational and Protective Structure Use, effective October 16, 2015; to allow for the removal of the retractable stairway and the construction of two aluminum stairways with railings, an aluminum gangway with railing, and a floating walkway and boat dock; and include special provisions related to the construction of boat docks; to revise the annual rent from \$143 to \$331 per year, effective August 23, 2016; and replace the existing Exhibit A, Land Description, and Exhibit B, Site and Location Map with the attached Exhibit A, Land Description, and Exhibit B, Site and Location Map (for reference purposes only); all other terms and conditions of the lease will remain in effect without amendment.

LAND DESCRIPTION

Two parcels of State owned land adjacent to Lot 19 of Tract No. 15640 as shown on Tract Map recorded in Book 261, Pages 88 through 94, inclusive of Maps, in the Office of the County Recorder of San Bernardino County, State of California, described as follows:

PARCEL 1

BEGINNING at the easterly corner of said Lot 19; thence northwesterly along the northeasterly line of said lot, said line also being the Agreed Boundary Line as described in Exhibit A of Document Number 92-333250, recorded on August 11, 1992, Official Records of said County, N 40° 58′ 03″ W 51.52 feet to the northerly corner of said lot; thence leaving said northeasterly line and said Agreed Boundary Line, along the northeasterly prolongation of the northwesterly line of said lot N 41° 11′ 45″ E 35.01 feet; thence S 44° 26′ 29″ E 54.09 feet to the intersection with the northeasterly prolongation of the southeasterly line of said lot; thence southwesterly along said northeasterly prolongation S 45° 33′ 31″ W 38.03 feet to the POINT OF BEGINNING.

EXCEPTING THEREFROM any portion lying waterward of the toe of revetment adjacent to said Lot 19.

PARCEL 2

BEGINNING at the easterly corner of said Lot 19; thence northwesterly along the northeasterly line of said lot, said line also being the Agreed Boundary Line as described in Exhibit A of Document Number 92-333250, recorded on August 11, 1992, Official Records of said County, N 40° 58′ 03″ W 51.52 feet to the northerly corner of said lot; thence leaving said northeasterly line and said Agreed Boundary Line, along the northeasterly prolongation of the northwesterly line of said lot N 41° 11′ 45″ E 90.00 feet; thence S 45° 33′ 40″ E 58.28 feet to the intersection with the northeasterly prolongation of the southeasterly line of said lot; thence southwesterly along said northeasterly prolongation S 45° 33′ 31″ W 94.00 feet to the POINT OF BEGINNING.


EXCEPTING THEREFROM any portion lying within above described PARCEL 1.
