#### RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF DECEMBER 18, 2015

Chair Gavin Newsom called the meeting of the California State Lands Commission to order at 1:30 P.M. at the Capitol Event Center, 2<sup>nd</sup> Floor, Sacramento, California 95814; also present were Commissioner Betty Yee and Commissioner Alternate Eraina Ortega.

The Minutes of the October 16, 2015 meeting were approved by a vote of 3-0 (Newsom-Yes; Yee-Yes; Ortega-Yes).

### **EXECUTIVE OFFICER'S REPORT**

Executive Officer Jennifer Lucchesi updated the Commission on the following items:

- The Commission is committed to the safety of its leases, grantees and stakeholders and the integrity of their facilities. Commission staff sent letters encouraging our leases, stakeholders, and regulated community to plan and prepare for El Niño events and also identified state resources to help them prepare for those conditions.
- The Poseidon desalination facility, located at Agua Hedionda in Carlsbad will begin commercial operations soon. This facility is the largest desalination facility in the western hemisphere, with production capacity of 50 million gallons of fresh water per day.
- Tentative meeting dates for 2016: February 9<sup>th</sup> in Sacramento, April 5<sup>th</sup> in San Francisco, June 7<sup>th</sup> in Sacramento, August 9<sup>th</sup> in Los Angeles, October 13<sup>th</sup> in San Diego, and December 6<sup>th</sup> in Sacramento.
- The Commission recently released the Commission's Draft Tribal Consultation Policy for public review and comment. This policy will establish a process for early collaboration and meaningful consultation with tribal officials on Commission actions with tribal implications.
- Jennifer DeLeon has been appointed as the Commission's new Science Policy Advisor and Tribal Liaison. Ms. DeLeon will coordinate activities across all the Commission's divisions and programs in the following areas: sea level rise adaptation, climate change, ocean health policy teams, and also leading the Commission's efforts on the greenhouse gas reduction and renewable energy opportunities.
- A brief summary was provided on the State Lands Commission's successes for 2015 across all divisions and programs, including surface leasing, oil spill and marine invasive species prevention, coastal hazard removal, abandoned mine remediation, legislation, land exchanges and acquisitions to enhance public access, and title settlements.

**ITEM C57:** A staff presentation was made to the Commission to consider an application for a General Lease – Recreational Use, of sovereign land located in Corte Madera Creek.

Item C57 – was approved as presented by a vote of 3-0 (Newsom-Yes; Yee-Yes; Ortega-Yes).

**ITEM C64:** A staff presentation was made to the Commission to consider an application for a General Lease – Recreational Use, of sovereign land located in Corte Madera Creek.

**ITEM 119:** A staff presentation was made to the Commission to consider sponsoring legislation to repeal a grant of public trust land made in 1977 to the City of Albany and enact a new grant of public trust land to the City that includes updated terms and conditions.

Item 119 – was approved as presented by a vote of 2-0 (Newsom-Yes; Yee-Yes; Ortega-Abstained).

**ITEM 122:** A staff presentation was made to the Commission to consider proposed adoption of regulations implementing statutory provisions that authorize administrative hearings to address unauthorized structures on State lands.

Item 122 – was approved as presented by a vote of 3-0 (Newsom-Yes; Yee-Yes; Ortega-Yes).

**ITEM 121:** A staff presentation was made to the Commission to consider proposed amendments and additions to the California Code of Regulations, Title 2, Division 3, Chapter 1, Article 4.8 – Biofouling management to minimize the transfer of nonindigenous species from vessels operating in California waters.

Item 121 – was approved as presented by a vote of 3-0 (Newsom-Yes; Yee-Yes; Ortega-Yes).

**ITEM 120:** An informational presentation was made to the Commission by Greg Murphy of the Maritime Alliance on its efforts to promote sustainable, science-based ocean and water industries.

Item 120 – was informational – no vote required.

**ITEM 124:** An informational presentation was made to the Commission to report on the status of negotiations to acquire a public access easement to and along Martins Beach near the City of Half Moon Bay in San Mateo County.

Item 124 – was informational – no vote required.

**ITEM 125:** An informational presentation was made to the Commission updating them on the status of the Becker Well at Summerland Beach, Santa Barbara County.

Item 125 – was informational – no vote required.

# RECORD OF ACTION CONTINUED

**ITEM 117:** A staff presentation was made to the Commission to consider adoption of the California State Lands Commission's 2016-2020 Strategic Plan. After hearing testimony from individuals in the public and private sector, the item was approved as presented.

Item 117 – was approved as presented by a vote of 3-0 (Newsom-Yes; Yee-Yes; Ortega-Yes).

**ITEM 123:** A staff presentation was made to the Commission to consider an application to terminate two existing leases for the intake and outfall structures at Diablo Canyon in San Luis Obispo County and issue an application for a new lease to cover those same facilities for a limited term. After hearing testimony from a PG&E representative and from members of the public, the Commission decided to defer the item and hear it at a future meeting.

Item 123 – was deferred by a 3-0 vote (Newsom-Yes; Yee-Yes; Ortega-Yes).
