CONSIDER GRANTING AUTHORITY FOR THE EXECUTIVE OFFICER TO EXECUTE AGREEMENTS FOR BUDGET FISCAL YEAR 2016-2017

PARTY:

California State Lands Commission 100 Howe Avenue, Suite-100 South Sacramento, CA 95825-8202

PROPOSED ACTIVITY:

The Executive Officer requests authority to execute Agreements for Budget Fiscal Year 2016-2017. The following contracts require renewal:

1. University Enterprises, Inc.

\$150,000

Contract No. C2016-01

Interagency Agreement with the University Enterprises Inc. to procure the services of college students to assist Commission staff with information technology (IT) services. The Commission's Information Services unit is staffed with 11 full-time positions yet supports approximately 275 end-users in the Commission's Northern and Southern California offices. The unit strives to maintain current service levels and accommodate new IT demands, including:

- Provide timely and dependable customer service;
- Assist Commission staff with project planning, implementation, and training;
- Support and manage current hardware and software;
- Keep abreast of new and emerging technology;
- Develop web-based public facing applications; and
- · Provide remote and wireless access.

In order to meet these demands, the Commission's Information Services unit needs staff augmentation from time to time. University Enterprises, Inc. provides college students specializing in IT to the Commission on a part-time basis to assist with the more basic IT needs. Not only does this allow the Information Services unit to redirect its limited, but more experienced staff to the more complex and time consuming tasks, it also gives the college students real world experience in a professional setting. Some of these students may later join the State workforce with directly relevant experience in State IT operations.

2. County Assessor's Records \$120,000 est. Contract No. C2016-02

Solicit a contractor to provide on-line access through an Internet connection to a real property search database of current County tax assessor's plat maps and ownership/sales records for all 58 counties in California. Agreement shall be for three fiscal years, subject each year to the availability of funds.

The Commission has jurisdiction and management over the State's navigable and tidal waterways, as well as certain lands granted to the State of California by the federal government under various Acts of Congress. Public and private entities may apply to the Commission for leases or permits on State lands for a variety of purposes. The Commission's Land Management Division routinely conducts title research (ownership, etc.), boundary determination, appraisals, and leasing as part of the management of lands under its jurisdiction. The records that can be accessed from such an on-line service are very important to these important operations.

All agreements shall be consistent with State policies and procedures as specified in the State Administrative Manual and State Contract Manual. All agreements are subject to sufficient funding provided in the Commission's budget. Multi-year agreement is subject each year to certification of the availability of funds.

Authorize the Executive Officer or her Designee to solicit bids and proposals for on-line access to County Assessor records, and award and execute a contract with the qualified bidder in accordance with competitive bidding requirements of the Public Contract Code and current State policies and procedures.
