RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF AUGUST 9, 2016

Chair Betty Yee called the meeting of the California State Lands Commission to order at 11:00 A.M. at the Port of Los Angeles, Board Hearing Room, Harbor Administration Building, 425 S. Palos Verdes Street, San Pedro, California 90731; also present were Commissioner Alternate Rhys Williams and Commissioner Alternate Eraina Ortega.

The Minutes of the June 28, 2016 meeting were approved by a vote of 3-0 (Yee-Yes; Williams-Yes; Ortega-Yes).

EXECUTIVE OFFICER'S REPORT

Executive Officer Jennifer Lucchesi updated the Commission on the following items:

- On August 5, 2016, Commission staff approved the vessel registered as Invictus
 to discharge untreated ballast water in the ports of Marina del Rey and Newport
 Beach for the purposes of maintaining stability. This approval was granted
 pursuant to the Commission's regulations. This approval by Commission staff
 expires on November 15, 2016, at which time the vessel must resume complying
 with the Commission's ballast water management standards.
- On August 8, 2016, Commission staff sent a letter to the State Water Resources Control Board expressing the Commission's support and encouraging full compliance of the state's once-through cooling policy and associated resolution by PG&E for the Diablo Canyon Power Plant offshore infrastructure for the interim time between now and license expiration.
- Commission staff and San Diego Unified Port District staff continue to make significant progress on the pilot marine planning framework effort. Commission staff anticipates bringing the draft MOA to the Commission for consideration at the October meeting.
- Commission staff is still in discussions with the Coastal Commission and other stakeholders on a new concept for an acquisition of access rights for the public to get down to the Martins Beach area.
- Venoco has requested an amendment to their oil and gas lease to adjust the
 easterly boundary of the lease premises to include approximately 3,400 acres in
 exchange for Venoco's quitclaim and release of approximately 3,800 acres into
 the coastal sanctuary. Commission staff is currently developing the Draft EIR for
 this project, and anticipate that it will be circulated for public comment towards
 the end of the third quarter, beginning of the fourth quarter of this year.
 Commission staff anticipates that the project will come before the Commission in
 the first quarter of 2017.

RECORD OF ACTION CONTINUED

- The Bolsa Chica wetlands restoration project will be celebrating the 10th
 Anniversary of the wetland restoration and the historic opening of the ocean inlet.
 The event will take place August 24th.
- The Prevention First Symposium, hosted by the State Lands Commission, will take place September 27th and 28th in Long Beach at the Westin. This year marks the 12th biennial Prevention First Symposium since its inception in 1994. The Commission has created a Twitter account and will be tweeting live updates for all the presentations going on at Prevention First.

While this was an informational item, Controller Yee asked staff to assist the Controller in convening a working group including staff from the Controller's Office, representatives from the Ports of Los Angeles and Long Beach, the Coalition for Clean Air, and other stakeholders to work on further policy guidance addressing public trust resources, particularly air quality and other port issues.

ITEM 60: A staff presentation was made to the Commission on the Port of Long Beach's community impact study and potential mitigation measures to address direct impacts of port-related operations on neighboring communities.

Item 60 – was informational – no vote required

ITEM 61: A staff presentation was made to the Commission consider adoption of a Commission Tribal Consultation Policy.

Item 61 – was approved as presented by a vote of 3-0 (Yee-Yes; Williams-Yes; Ortega-Yes)

ITEM C34: A staff presentation was made to the Commission to consider a General Lease – Other Use, of sovereign land located in Huntington Harbour, Huntington Beach, Orange County. After hearing testimony from the applicant the Commission deferred action on the item.

Item C34 - was deferred, to be considered at a future meeting by a vote of 3-0 (Yee-Yes; Williams-Yes; Ortega-Yes)
