REVISION OF RENT

LESSEE:

Michael M. Ghilotti and Lisa B. Ghilotti

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 7762 North Lake Boulevard, near Tahoe Vista, Placer County.

AUTHORIZED USE:

Continued use and maintenance of two existing mooring buoys.

LEASE TERM:

10 years, beginning January 26, 2012.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$680 per year to \$754 per year, effective January 26, 2017.

OTHER PERTINENT INFORMATION:

1. Lessee owns the upland adjoining the lease premises.
2. On January 26, 2012, the Commission authorized a General Lease – Recreational Use to Michael M. and Lisa B. Ghilotti for a term of 10 years beginning January 26, 2012. The lease will expire on January 25, 2022.
3. Staff conducted the rent review called for in the lease, and recommends annual rent be increased.
4. This action is consistent with Strategy 2.1 of the Commission’s Strategic Plan to optimize returns for the responsible development and use of State lands and resources, both onshore and offshore.

5. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

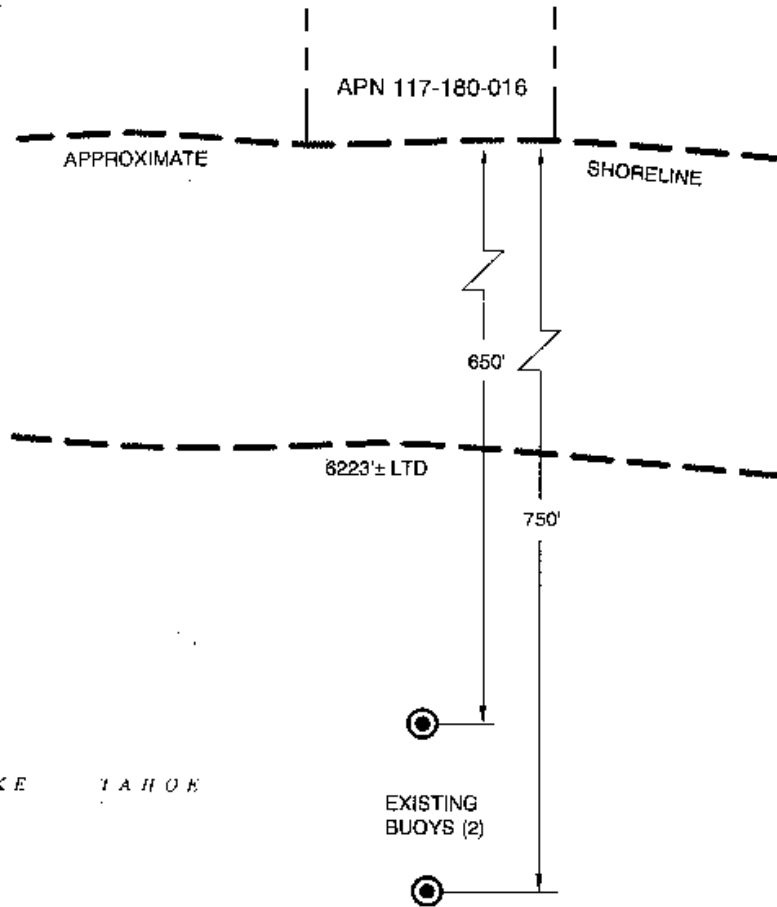
LAND DESCRIPTION PLAT

LOCATION

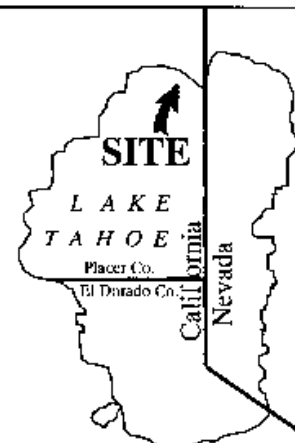
