REVISION OF RENT

LESSEE:

AT&T Corp.

AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Pacific Ocean, offshore of Manchester State Beach, Mendocino County.

AUTHORIZED USE:

Continued use and maintenance of five 5-inch-diameter steel conduits and two fiber optic cables (Segment 8 and Segment 9) within two 1.2-inch-diameter steel conduits.

LEASE TERM:

15 years, beginning July 1, 2010.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff reviewed the rent under this lease and recommends that rent be revised from \$239,857 per year to \$412,332 per year, effective July 1, 2017.

OTHER PERTINENT INFORMATION:

- 1. Lessee has the right to use the upland adjacent to the lease premises.
- On October 29, 2010, the Commission authorized a General Lease Non-Exclusive Right-of-Way Use to AT&T Corp. for a term of 15 years beginning July 1, 2010 (<u>Item C50, October 29, 2010</u>). The lease will expire on June 30, 2025.
- 3. Staff reviewed the rent called for in the lease and recommends the rent be increased to \$412,332 per year, effective July 1, 2017. The increase in annual rent is based on \$5.00 per linear foot for fiber optic cables as determined by a staff appraisal.

- 4. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 5. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.


A. Site and Location Map
