REVISION OF RENT

LESSEE:

Liberty Utilities (CalPeco Electric) LLC

AREA, LAND TYPE, AND LOCATION:

1.153 acres, more or less, of sovereign land in Lake Tahoe, adjacent to Assessor's Parcel Numbers 018-041-04 and 018-060-05, near Emerald Bay, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing 4.5-inch-diameter submarine electrical power cable and the retention and maintenance of an existing 3-inch-diameter inoperable submarine electrical power cable abandoned in place.

LEASE TERM:

20 years, beginning December 1, 2002.

CONSIDERATION:

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff reviewed the rent under this lease and recommends that rent be revised from \$1,185 per year to \$1,290 per year, effective December 1, 2017.

OTHER PERTINENT INFORMATION:

On June 18, 2002, the Commission authorized a General Lease – Right-of-Way Use to Sierra Pacific Power Company for a term of 20 years beginning December 1, 2002 (<u>Item C11, June 18, 2002</u>). On August 24, 2006, the Commission authorized an Amendment of Lease for the retention of the existing 3-inch-diameter inoperable submarine power cable abandoned in place and the installation of a new 4.5-inch-diameter submarine power cable (<u>Item C19, August 24, 2006</u>). On June 23, 2011, the Commission authorized an Assignment of Lease to California Pacific Electric Company, LLC (<u>Item C64, June 23, 2011</u>). In 2013, the Lessee changed its name to Liberty Utilities (CalPeco Electric) LLC as a result of corporate restructuring. The lease will expire on November 30, 2022.


A. Site and Location Map
