### **REVISION OF RENT**

#### LESSEE:

Jaime Favila Jr. and Kathryn A. Favila

# AREA, LAND TYPE, AND LOCATION:

Sovereign land located in the Sacramento River, adjacent to 7140 Pocket Road, city of Sacramento, Sacramento County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing uncovered boat dock and three pilings with metal bracing.

# **LEASE TERM:**

10 years, beginning December 12, 2012.

#### **CONSIDERATION:**

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$76 per year to \$125 per year, effective December 12, 2017.

#### OTHER PERTINENT INFORMATION:

- On April 26, 2013, the Commission authorized a 10-year General Lease Recreational Use to Jaime Favila Jr. and Kathryn A. Favila, for an existing uncovered boat dock and three pilings with metal bracing (<u>Item C34, April 26, 2013</u>). That lease will expire December 11, 2022.
- 2. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 3. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

TOGETHER WITH a 10 foot impact area.




