CONSIDER ACKNOWLEDGMENT OF RECEIPT OF THE FULL QUITCLAIM DEED FOR NEGOTIATED SUBSURFACE (NO SURFACE USE) OIL AND GAS LEASE NO. PRC 8618.1

LESSEES:

Summit Exploration (California), LLC

Stream Energy, Inc.

AREA, LAND TYPE, AND LOCATION:

Negotiated subsurface (no surface use) Oil and Gas Lease No. PRC 8618.1 contains approximately 37.41 acres of tide and submerged lands situated in the bed of the Sacramento River and Georgiana Slough in Sacramento County (Exhibit A attached).

BACKGROUND AND ANALYSIS:

Authority: Public Resources Code section 6804.1

On June 20, 2005, the Commission approved a negotiated subsurface (no surface use) Oil and Gas Lease No. PRC 8618.1 (Lease) with Stream Energy, Inc. (Stream) (Item C45, June 20, 2005). The original lease contained approximately 17.91 acres of tide and submerged lands in the bed of the Sacramento River and Georgiana Slough in Sacramento County.

On March 25, 2008, the Commission approved an amendment to add approximately 19.5 acres to the lease for a total of 37.41 acres and pooled all of the leased lands into two units, the CT-KD Unit and Shoreline Pooling Unit (ttem C84, March 25, 2008). The annual rental for the entire lease is \$950 and the royalty is fixed at 20 percent on all gas and oil produced.

During 2007 and 2008, Stream drilled three wells, of which two were drilled through State land and one was drilled adjacent to State land. Stream drilled one natural gas well, the Walnut Grove 34-1, through the leased lands from a location on private land west of the leased lands. Stream also drilled two wells from private land, the Kay Dix 35-1 with a bottom hole on the leased land, and Kay Dix 35-2, with a bottom hole adjacent to the leased lands.

STAFF REPORT NO. C70 (CONT'D)

On November 12, 2008, well Kay Dix 35-2 was plugged and abandoned by Stream, as witnessed and approved by the California Division of Oil, Gas, and Geothermal Resources' (DOGGR) standards and procedures (Exhibit F attached).

On June 30, 2017, staff received the full Quitclaim Deed from both Summit and Stream, dated April 13, 2017, which quitclaimed back to the State the entirety of Lease PRC 8618.1 (Exhibit C attached). However, at that time, the remaining wells on and through State lands were not plugged and abandoned in compliance with lease provisions and DOGGR standards and procedures.

On October 3, 2017, pursuant to the Commission's lease provision standards, wells Walnut Grove 34-1 and Well Kay Dix 35-1 were plugged and abandoned by cementing the producing zones within lands under the State's jurisdiction (Exhibits D and E, attached). Those wells are no longer capable of producing gas from the leased lands; however, the operator has not completed the final plugging and abandonment requirements near the surface of each well, located on private upland property. Therefore, the wells are considered idle wells by DOGGR standards and procedures; however, because the zones of production on State sovereign lands are properly isolated, the operator has satisfied its lease-related abandonment obligations.

A review of the Commission's files reveals that no defaults exist on the Lease, and that the Lessees have otherwise complied with all applicable laws and Lease terms including abandonment of those portions of the wells on State property.

Public Resources Code section 6804.1 and Lease Paragraph 29 permit the Lessees to make, at any time, a written quitclaim of all rights under the Lease. The quitclaim is effective when filed with the State on June 30, 2017. Staff presents this Staff Report and authorization to acknowledge and confirm the completion of the Lessees' obligations under the lease so that staff may properly release held performance bonds or other guarantees held under the lease.

STAFF REPORT NO. C70 (CONT'D)

OTHER PERTINENT INFORMATION:

- 1. This action is consistent with Strategy 1.1 of the Commission's Strategic Plan to deliver the highest levels of public health and safety in the protection, preservation, and responsible economic use of the lands and resources under the Commission's jurisdiction.
- 2. Acceptance of the quitclaim deed is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

- 2. Find that Summit Energy, LLC, and Stream Energy, Inc., have complied with all obligations under Oil and Gas Lease No. PRC 8618.1.
- 3. Release both Summit Energy, LLC, and Stream Energy, Inc., from all obligations under Oil and Gas Lease No. PRC 8618.1.
- 4. Authorize the Executive Officer or her designee to execute any documents necessary to implement the Commission's action.
